Candidates obtaining a valid score (Marks out of 100) shall only be eligible for the next stage of selection. The score is valid only if the candidate obtains more than or equal to the qualifying marks as fixed for **GATE 2016** paper.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their normalized marks (Out of 100) in the corresponding paper of GATE 2016.

Candidates shortlisted for the Group Discussion and Interview shall be required to submit the documents as may be mentioned in the call letter.

Final merit list shall be prepared as per following weightage distribution:

Only those candidates shall be considered for empanelment who secure a minimum of 60% marks in Interview (50% for SC/ST/OBC/PWD). Group Discussion (GD) will not have any qualifying marks.

The Offer of Appointment shall be issued to the suitable candidates in the order of category wise merit and based on requirement.

Please note that only GATE 2016 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2015 or prior is not valid.

Appointment of selected candidates will be subject to their being found medically fit in the Medical Examination to be conducted as per RITES Rules and Standards of Medical Fitness for the relevant post.

Candidates have the option to appear for interview either in Hindi or English.

Nature & Period of Engagement

Selected candidates will be on training for a period of 2 months. The candidates will be required to successfully clear the examination to be conducted at the end of training.

On successful completion of training and passing the examination, the candidates will be engaged as Assistant Manager in IDA pay – scale of Rs.20600-46500 on probation for a period of 2 years. Candidates will be required to successfully clear the screening for confirmation of their services at the end of the probation period
