GENERAL TERMS & CONDITIONS

1. Age Relaxation.

- (a) Relaxation of upper age limit of 5 years (18 to 30 years) for the post reserved for SC is admissible.
- (b) Age relaxation for Physically Handicapped (Hearing Handicapped) and Central Government Servants is applicable as per the Government orders.
- (c) No age relaxation is admissible to SC/ST/OBC candidates who apply against unreserved posts.
- (d) No age concession is admissible to the Sons, Daughters and Dependents of Ex-Servicemen.
- (e) Age relaxation to all persons who had ordinarily been domicile in the state of Jammu & Kashmir during the period from 01 Jan 1980 to 31 Dec 1989 will be permissible for 5 years.
- 2. <u>Reservation.</u> SC Candidates who have applied against reserve category are required to submit a valid certificate regarding their caste status.

3. Physically Handicapped Persons.

- (a) Only such persons would be eligible for reservation who suffer from 40% or more of hearing disability for PH (HH) category. A person who wants to avail benefit of reservation is required to submit the 'Permanent' disability certificate issued by a Medical Board duly constituted by the Central or State Government.
- (b) A Medical Board consisting of at least 3 members, out of which, at least one member shall be a Specialist from the relevant field.
- (c) Candidate under PH (HH) quota will be adjusted in Unreserved category only. PH (HH) category candidates belongs to SC/ST/OBC may apply for the post reserved for HH who will be considered for 'UR' category.
- 4. **Syllabus.** A common pattern of Syllabus/ Procedure for Written Examination / typewriting test in the recruitment of Lower Division Clerk is enumerated as under:-
 - (a) <u>Written Examination</u>: The written examination will consists of the following tests:-



<u>Note</u>: The questions in all the four tests will be "Objective-Multiple-Choice-Type". Candidates will be required to qualify in each of the four tests separately. Minimum qualifying marks in each of the four tests will be 09 (nine) having aggregate of 40 marks in overall tests.

(b) <u>Typing Test</u>: The typewriting test will be a qualifying test only. The typewriting test will consist of one paper on running matter of 10 minutes duration. Qualifying speed for typing test is not less than 35 words per minutes in English or not less than 30 words per minute in Hindi typewriting.

5. **Short Listing**.

- (a) If the number of applications received in response to the advertisement is large, appointing authority or the Commandant, National Defence Academy Khadakwasla reserves the right to restrict the number of candidates to a reasonable limit on the basis of percentage of marks obtained in 12th class.
- (b) The applications accepted on scrutiny will be shortlisted based on the essential qualifications/experience required and shortlisted candidates will only be called for test. All selection tests will be conducted at NDA Khadakwasla, Pune.
- (c) On completion of skill test (eligibility test in typing) and written test candidates will be shortlisted based on their performance in written test.
- (d) Candidates Should note that no extra weightage will be given for any additional higher qualifications other than the prescribed minimum qualification or experience which also does not vest any right in a candidate for being called for test.

6. Selection Procedure.

- (a) A select panel equal to the number of vacancies notified and based on the performance of candidates will be drawn up. Candidates on the select panel will be offered an appointment subject to medical fitness on medical examination and other satisfactory requirements before actual appointments. The reserve panel will be applicable strictly as per merit only.
- (b) Date of tests will be communicated to all eligible shortlisted candidates.
- 7. <u>Enclosures</u> The following enclosures are to be firmly stitched alongwith the application form:-
 - (a) Self attested photocopies of certificates / documents as mentioned in the Application Form (Annexure) including caste certificate.

INSTRUCTIONS

8. **General**.

- (a) The candidates applying for the post must note that the DSC terms and engagement of service will have to be adhered to as per Instructions from DSC Records Office and Central Civil Services Rules.
- (b) Those working in Government Establishments, Public Sector Undertakings and Autonomous Bodies should only apply through proper channel alongwith the NOC from their establishment, with a certificate that no disciplinary action is contemplated / pending against them and they have no objection in releasing them in case of selection. Advance applications will not be considered. A no objection certificate from the Establishment should be enclosed with the application.
- (c) The following acts/omissions would render a candidate/ application to be disqualified at any stage of selection procedure:-
 - (i) Application not in prescribed format or incomplete or unsigned or undated or improperly filled or hand written or without signed declaration.
 - (ii) Furnishing of false, inaccurate or tempered or dubious information.

 - (iv) If not subscribed with the name of the post/category applied for or incorrect name of the post on the envelope.
 - (v) Any other deemed irregularity or reason as observed by the Board of Officers.
