UNIVERSITY... AT A GLANCE

The University of Saugor later renamed as Dr. Harisingh Gour Vishwavidyalaya was established in July 1946 by the great visionary Dr. Sir Harisingh Gour by his single handed donation at Sagar (M.P.). The University is one of the prestigious Universities of central India and achieved the Central University status on January 15, 2009, situated in a rural and sub-urban environment in the heart of the country. The university has been a centre of higher learning. Honorable President of India is its Visitor. Being the sixteenth university of the country and the first of the state of Madhya Pradesh, the founder and mentor Dr. Gour desired to establish an educational institution for rural and deprived population of Central India. The model of education as conceived by the founder is to bring its standard like Cambridge and Oxford universities.

The University campus spreads over an area of about 1300 acres on the top of hills, surrounded by lush green forests having natural and pollution free environment. It testifies the foresight and dream of Dr. Sir Harisingh Gour.

University has adopted the International mode of education system. Ten schools established under this new system offers courses ranging from Natural to Physical Sciences, Applied Sciences and Technology, Law, Business Management, Applied Geology, Pharmaceutical Sciences, Humanities, Arts, Social Sciences, Music and Performing Arts and Educational studies. Nationwide competition through entrance tests for admission in Undergraduate, Postgraduate and Research held at different corners of the country has been attracting young talents. The Ten schools with more than 36 independent departments, choice based credit system (CBCS) offers undergraduate and post graduate courses in different disciplines. The university has a privilege of having additional grants provided by UGC, SAP, FIST, DRS, DSA, COSIST or CAS etc.

There are four hostels for men and two for women. University provides residential facility for employees of all cadres. Our first Prime Minister Pt. Jawaharlal Nehru laid down the '*foundation stone*' of the university library in 1952 and the Library was named after his name. This library has a collection of more than four lakh books with electronic and internet facility.

There are excellent museums in the teaching departments of Applied Geology, Ancient Indian History, Anthropology, Zoology and a Botanical Garden which is recognized by the BGCI Kew, U.K.

The University has its own water supply system. The health centre of the University renders valuable clinical services to the students and residents of the campus. The University has its own printing press and SBI branch, Post Office, Telephone Exchange, Employment and Guidance bureau in the campus. The University has an auditorium for indoor games and big playground for outdoor games, as well as an ultra-modern well-equipped and furnished "*Golden Jubilee Hall*" with a seating capacity of 750 persons for cultural and academic activities.

The University has various centers for developmental activities such as Academic Staff College, Central Instrumentation laboratory, a Centre of Indira Gandhi Open University (IGNOU), Educational Multimedia Research Centre (EMMRC), Population and Research Centre (PRC) of Ministry of Health and Family Welfare and Manuscriptology Research Centre of the Ministry of Culture, Government of India.

Several alumni of the University have brought great glory by distinguishing themselves in their chosen fields both within and outside the country. More than twenty five of its students and teachers had been Vice Chancellor of different Indian Universities and Director General to Geological Survey of India, Government of India. A number of top ranking television and Cine artists also belong to this university.

Sagar city, situated about 200 km away from Jhansi (U.P.) and Bhopal (M.P.) (between Bina-Katni sections of Central Railway), is well connected by road and rail. Thus the university provides an excellent academic atmosphere like "*Gurukul*" to youth.

Part A

1. Guidelines for admission to M.Phil. Courses:

Dr. H.S. Gour University invites applications for admission to M.Phil. and Ph.D. programme in following subjects through entrance test

Philosophy (10 seats), 2. Sociology (10 seats), 3. English (8 seats) 4. Hindi (20 seats)

1.1 Duration of Course : One year (Two Semesters)

1.2 Structure of M.Phil. program :

- i. **Core courses** compulsory to all (Minimum two courses) carrying 5 credits each
- ii. **Elective courses** (one): carrying 5 credits each.
- iii. **Dissertation** 21 credits (Compulsory) Second semester

The total number of credits for core and elective shall be 15 in first semester.

Note: The departmental post graduate committee may specify the credits for core courses (including dissertation and Viva-Voce) subject to the minimum limit of **36 credits**.

The research topic for **the dissertation** is finalized even at the beginning of first semester so that the collection of relevant literature and research design could be completed in first semester leaving entire second semester for research.

1.3 Eligibility :

The candidates willing to take admission to M.Phil. program, should have following qualification :

1.4 Qualifications:- Candidates who have secured at least **55% marks (without rounding off)/6.0 CGPA in (0-9) Ten point grade scale, for General and OBC (NCL), in Master's Degree** or equivalent examination from Universities / Institutes recognized by UGC are eligible to appear in the Entrance Test. **Schedules Caste (SC)/ scheduled tribes (ST)/Physically Handicapped (PH)/Visually Handicapped (VH) category students who have secured 50% marks (without rounding off)/5.0 CGPA in (0-9) Ten point grade scale, in the Master's degree** or equivalent are eligible to appear in the test.

1.5 Age Limit:- Maximum upto 28 years as on 01/07/2012 Upper age limit may be relaxed upto five years in case of candidates belonging to SC/ST/OBC (Non creamy layer) PH,VH and Female.

Note: The admission would be given on the basis of "Merit" only, evaluating the performance of the candidate in the interview conducted by the department concerned.

Part B

2 Ph.D. Course: Ph.D. course is conducted by almost all the departments of different schools. Admission is subject to availability of seats with faculty members. The number of seats may vary from year to year.

2.1 Duration of the Course:

A research scholar registered to the course will have to pass one year – (Two Semesters) course work followed by two years research work.

2.2 Structure of the Ph.D. Course:

Total Course Credits = 80

Credits through course work for each semester = 24 (Minimum)

(4 courses x 4 credits = 16 credits through course work + 8 from research work/ Project / Seminar etc. in each semester).

Total course work credits = 48 (in two semesters).

Credits through Research = 32 ((Minimum) after two semesters).

Minimum Period = 5 Semesters

Maximum duration = 5 Years (including One year extension)

- A department may prescribe, with prior approval of the APC, additional credits of courses/thesis over and above the minimum specified as above.
- Allotment of supervisors, Course Work, Ph.D. Thesis evaluation, etc. would be done as per the Ph.D. program of Dr. Hari Singh Gour University.

2.3 Eligibility:

2.3.1 **Qualification:** Candidates who have secured at least **55% marks (without rounding off)/6.0 CGPA in (0-9) Ten point grade scale, for General and OBC (NCL), in Master's Degree** or equivalent examination from Universities / Institutes recognized by UGC are eligible to appear in the Entrance Test. **Schedules Caste (SC) / Scheduled Tribes (ST) / Physically Handicapped (PH)/Visually Handicapped (VH) category students who have secured 50% marks (without rounding off)/ 5.0 CGPA in (0-9) Ten point grade scale in the Master's degree** or equivalent are eligible to appear in the test.

2.3.2 **The candidate studying in the last semester of the qualifying examination may also apply, but he/she must have to produce final result before the date of interview, failing which his / her candidature will automatically stand cancelled.**

2.4 AGE LIMIT:-

2.4.1. **Upper age limit is 28 years as on 01/07/2012**

2.4.2 **There is a relaxation in upper age limit up to 5 years** in case of candidates belonging to (a). SC/ST/OBC (Non creamy layer), (b). PH/VH and (c). Female candidates.

2.4.3. **There is a relaxation of 3 years in upper age limit for LL.M. candidates.**

2.4.4 There is no upper age limit for NET qualified candidates and also for others falling under the category mentioned below : (as per para 6 (page 3) of the Ph.D. program) ***“A candidate who is a recipient of National Doctoral Fellowship or other fellowships from government/semi-government organization such as Council of Scientific and Industrial Research(CSIR), University Grants Commission (UGC), All India Council for Technical Education (AICTE), Department of Science and Technology (DST), Defense Research and Development Organization (DRDO), Department of Atomic Energy (DAE), Department of Biotechnology (DBT), Indian Council of Agricultural Research (ICAR), Indian Council of Medical Research (ICMR), Aurveda Yoga Unani Siddha Homeopathy (AYUSH) and similar national-level organizations accredited by UGC”***

2.5 Admission to Ph.D. course:

The admission to Ph.D. Course would be given by the following methods

4.1. Direct admission (without entrance examination but through interview)

4.2. Through Entrance Test followed by interview

2.5.1 Direct Admission: A candidate who fulfils one of the following requirements may be considered for direct admission to the Ph.D. programme without appearing in the entrance test, but through the interview.

- i. A candidate who is qualified in a national-level test such as National Eligibility Test NET-(JRF), or equivalent to national-level test.
- ii. The candidates having M.Phil./M.Tech. degree (admitted M.Phil./ M.Tech. degree by All India level Entrance Test and passed M.Phil. through CBCS system) with not less than 6.0 CGP in 10 point (0-9) grade slab, shall be directly admitted to Ph.D. program subject to a successful oral presentation at the ***interview / viva-voce*** conducted for such purpose by the DPGC and approved by APC afterward. The candidate(s) must be in possession of ‘Minimum Specified’ marks/grade point at the Master’s Degree.
- iii. A candidate who is a recipient of National Doctoral Fellowship or other fellowships from government/semi-government organizations such as Council of Scientific and Industrial Research(CSIR), University Grants Commission (UGC), All India Council for Technical Education (AICTE), Department of Science and Technology (DST), Defense Research and Development Organization (DRDO), Department of Atomic Energy (DAE), Department of Biotechnology (DBT), Indian Council of Agricultural Research (ICAR), Indian Council of Medical Research (ICMR), Aurveda Yoga Unani Siddha Homeopathy (AYUSH) and similar national-level organizations.
- iv. A candidate who is selected under Quality Improvement Program (QIP) of AICTE, Faculty Development Programme (FDP) of UGC provided that he / she has obtained appropriate study leave.
- v. A candidate who is sponsored as a full-time candidate by any other university institution/college/government department/public sector undertaking/ R&D organization, provided that the he/she has obtained appropriate study leave for pursuing Ph.D. programme in a Department/ School of the University.

- vi. A foreign national who is a recipient of fellowship by Indian Council for Cultural Relations (ICCR), Government of India and is sponsored by his/her government.
- vii. A self-financing foreign national who is admitted through the Embassies/High commission of his/her country after getting approval from the Ministry of External Affairs and 'No Objection Certificate' from the Department of Higher Education, Ministry of Human Resources Development, Government of India or admitted under an MOU.
- viii. A candidate who is already registered as a Ph.D. scholar in some other university and whose supervisor joins this University. Such candidates must have admitted through the Entrance Test and have adopted course work of Ph.D. program in their Parent University / Institution.
- ix. A candidate who is sponsored as a part-time candidate by a non-degree awarding institution/government department/public sector undertaking/R & D organization. who shall work for his/her Ph.D. in his/her parent organization fulfilling the residency period requirement prescribed in the relevant ordinances. The candidate is required to submit a sponsorship and work experience certificate from the parent organization. The non-degree awarding institutions, government departments, public sector undertakings, R & D organizations are only those, which are recognized as centers of research by the University as specified in the Ordinances.
- x. Teachers/Govt. Servants will be permitted to pursue Ph. D. Program with necessary eligibility and qualifications subject to the permission and requisite leave from their parent department for the period of Ph. D. Program as it is a full time course.

Note:

- **Candidates seeking admission in any of the above categories will be selected subject to their successful performance in the Interview Boards. Such candidates must apply within the last date of advertisement only.**
- **The number of seats in Ph.D. program through direct admission is 50 % of the total vacant seats, subject to the availability of candidates. The candidates under direct admission category desirous of university fellowship must appear and qualify the Entrance Test conducted by the university on same terms and conditions framed for entrance test.**

3. RESERVATION:

Candidates belonging SC, ST, OBC (if they belong to Non Creamy layer (NCL) and Physically Challenged (PC) categories will be given reservation as per the Government of India rules. ST(7.5%), SC (15%) and OBC (27% [excluding creamy layer]); 3% seats are reserved within each of the categories (for Physically / Visually / Hearing Challenged (PC) categories (on horizontal basis), only if the candidate fulfills the other minimum eligibility at the time of Entrance Test. Submission of a certificate to the effect issued by a competent authority/Board (details are given under point 5 of this bulletin) shall be mandatory, at the time of Interview. Kashmiri Migrants will be given certain concessions in matter of admission as per the MHRD letter **(No.3-1/2012-NER)**, D.O. No. F-10-1/10-Desk (U) dated Feb.2, 2011. In case the reserved seats in the OBC-non creamy layer are not filled, they can be filled by General category candidates. In case of PC of any category, the disability benefit would be given to those who have at least 40% physical impairment. The percentage of disability of the candidate should certified by the competent authority.

4. Certificate Required For Reservations

(i) Scheduled Castes/Scheduled Tribes

Each SC/ST candidate shall have to submit a self attested copy of the Certificate mentioning that the candidate belongs to SC/ST community. Such certificates shall be subject to verification from the concerned District Magistrate. The following are empowered to issue the certificate;

- (a) District Magistrate / Additional District Magistrate / Collector/ Deputy Commissioner / Additional Deputy Commissioner / Deputy Collector / First Class Stipendiary Magistrate/ City Magistrate/ Sub-Divisional Magistrate/ *Taluka* Magistrate / Executive Magistrate/ Extra Assistant Commissioner.
- (b) Chief Presidency Magistrate/Addl. Chief Presidency Magistrate/Presidency Magistrate.
- (c) Revenue Officer not below the rank of Tehsildar.
- (d) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.
- (e) Administrator/Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

Candidates must note that Certificate from any other person/authority shall not be accepted in any case. If the candidate happens to belong to SC or ST, his/her caste/tribe must be listed in the appropriate Govt. of India schedule. The caste Certificate should clearly state: (a) Name of his/her caste/tribe (b) whether he/she belongs to SC or ST (c) District and the State or Union Territory of his/her usual place of residence and (d) the appropriate Govt. of India schedule under which his/her caste/tribe is approved by it as SC or ST. The candidate should satisfy the minimum eligibility requirement for that category.

(ii) Other Backward Classes (OBC)

The candidates belonging to OBC category with Non Creamy Layer (NCL) as listed by the Central Govt., must submit the certificate issued by the competent authority. The OBC certificate should clearly mention that the candidate belongs to **non creamy layer (NCL)**.

(iii) Physically Challenged

Physically Challenged Candidates: Visually Impaired and/or Hearing Impaired and/or Orthopedically Handicapped (on horizontal reservation basis) candidates, have to submit an attested copy of Disability Certificate issued by the District Chief Medical Officer/Medical Board.

5. General Notes:

- (i) All Ph.D. Scholars shall be governed by the Ph.D. Program prescribed by the University.
- (ii) No full-time Ph.D. scholar shall accept during the period of research any paid assignment apart from Research Fellowships, Research Assistantships, Senior Resident ship / Service Senior Resident ship etc.
- (iii) A Ph.D. scholar shall not be permitted to join any other degree course, however, he / she may be permitted to join part-time Diploma or Certificate Course(s) as per provisions made under the relevant Ordinances.

6. Conduct of Entrance Examination:

Note: Entrance examination shall be conducted on June 1, 2012 only at UTD Center. Time: 09.00 am to 12.30 pm

6.1 Structure of the Test:

For Entrance Examination there would be two papers i.e. **Paper I and Paper II** and an **Interview** by Committee Composed of Dean and DPGC.

The interview is conducted out of 50 marks.

Paper I General Aptitude test of 50 questions with 100 marks (Applicable to all candidates offering any subject areas) .

Standard of passing: Mandatory to score minimum 50% marks for General and 45% for SC/ST/PH/VH category.

Paper will contain 50 objective MCQ type questions covering Logical Reasoning, Numerical Ability, Reasoning and Language Aptitude, Aptitude Test, General information on General Knowledge and its interface with society, candidate's awareness of scientific and quantitative reasoning aptitude, analytical approach etc. Questions would be so designed to judge the creativity, analytical ability, reasoning ability, comprehension, divergent thinking, general awareness and research aptitude of a candidate, Common elementary computer science, a few questions dealing with basic computer awareness and uses, **programming instructions and simple algorithms, computational methods.**

Paper 2 Subject Specific Test: This paper will be of 200 marks consisting of 100 objective (MCQ) type questions covering relevant subject in the faculty.

The syllabus for Art / Humanities subjects would be same to that U.G.C./NET while in Science the syllabus would be as per C.S.I.R/ NET.

Note :

- Merit list of successful candidates declared on the basis of marks obtained in paper I (50% or above compulsory or 45% or above as the case may be) **plus** marks obtained in Paper II **plus** marks obtained in Interview.
- NET-JRF qualified Candidates though exempted from written test but need to apply in the stipulated time mentioned in the advertisement. Appearance in interview is mandatory to all those seeking admission to Ph.D. course.
- CBCS qualified M.Phil. Candidates with minimum CGPA 6.0 in (0-9) ten point grade scale are exempted from written examination; however, they will have to appear in interview.
- Minimum overall cut-off marks **should in no case** be less than 50% (45% for specified reserved categories) of the total marks in entrance examination. (Paper I + Paper II + Interview)

8. Important Instructions To Candidates Appearing In Entrance Test–

1. The Candidate must carry his/her valid Admit Card for the concerned Entrance Test. He/She may occupy only his/her allotted seat as per his/her Roll Number in the seating arrangement made for the concerned Test.
2. No Candidate will be allowed entry to the Test Hall after 30 minutes of the start of the entrance Test.
3. No Candidate shall be allowed to leave the Test Hall till the end of the Test.
4. There is no provision to provide or permit a 'writer' in the Entrance Test except for blind candidates who will be provided "writers" on request.
5. The Candidates shall be checked for any resource materials frequently and at random by the invigilators and other staff conducting the Test, routinely and also on the slightest doubt.
6. Calculators/watch calculators, electronic diary, pager, mobile phones, earphones, alarm clock digital watches with memory, slide rule, etc. are not allowed in the examination hall. Also carrying of licensed weapon, fire arms, tools which can be used as lethal weapons are not allowed in the examination hall.

7. Any of the following actions by a candidate shall disqualify him/her to take the Entrance Test and the result of his/her Entrance Test shall be cancelled and he/she will also be debarred from future Entrance Tests of the University:-

The candidate must ensure that he/she is qualified to appear in the entrance Test. If it is detected at any stage that he/she did not fulfill the minimum qualifications, or, there was something against the candidate which would have prevented him/her from being admitted in the concerned subject, or, the candidate has provided false information or no information about his/her previous involvement in an act punishable under law or act of gross misconduct and indiscipline, then his/her candidature shall not be considered and his/her admission if already made shall be cancelled at any stage and he/she shall be debarred from appearing in any of the future Entrance Test of the University.

9. No scrutiny/re-evaluation of answer sheet of the Entrance Test is allowed in any case at any stage.
10. The candidate shall be bound by the Sagar University Statutes/Ordinances/Rules and Regulations framed from time to time.

9. Other Important Information

- i). Degrees/Certificates recognized by Association of Indian Universities (AIU)/Boards of secondary Education, shall only be deemed as equivalent degrees/certificates.
- ii). Application Forms of candidates who have submitted forged/fake certificates or adopted fraudulent means shall be REJECTED. Further, such candidates shall be debarred from appearing in any subsequent Entrance Tests conducted by Dr. H. S. Gour University, Sagar, and further matter will be reported to Police.
- (iii) As ***candidates are allowed to appear in the Entrance Tests provisionally***, it would be the responsibility of the candidate to furnish correct information, as no scrutiny of the application forms would be done before entrance test examination. The final verification of Mark sheets/Degrees/Certificates, validity of Certificates/Mark sheets of Qualifying Examination and also non-involvement in the adoption of unfair means in any of the University Examination/Entrance Tests held earlier, will be made at the time of interview.
- (iv) Mere appearance in the Entrance Test, or securing pass marks at the entrance Test does not entitle candidate to be considered for admission to the Course unless he/she fulfils the other eligibility conditions. Applicants must fully satisfy themselves about their eligibility as prescribed above, before filling in the application form. **It shall be the responsibility of the Candidate himself / herself, to thoroughly go through the rules / conditions regarding Eligibility, Age limit, caste category, and selection of subject etc.,**
- (v) If an applicant appears in the Entrance Test who otherwise does not fulfill the minimum eligibility requirements, at the time of submitting his or her application, however, acquires requisite qualification later and produces the relevant document of the same at the time of registration, his or her candidature may be considered for admission.
- (vi) The University reserves the right to cancel/refuse admission at any point of time if it is found that: (a) Minimum eligibility requirements are not fulfilled. (b) False documentation has been done, or, facts have been suppressed or distorted. (c) Any other valid reason.

10. Instructions For Completing The Application Form

10.1 APPLICATION FORM: The candidate should print/download the application form M.Phil./Ph.D. Entrance Test - 2012 and send to the concerned Head of departments.

10.2 Rejection Of Application Form And Candidature: The following are the grounds for rejection

1. Non-submission of hard copy of the bank Challan form for Fees Bank Challan
2. Non-submission of hard copy of DOB Proof
3. Non-submission of hard copy of Cast Certificate
4. Non-submission of hard copy of NET-JRF (Other national Scholarship Holder) Eligibility Certificate
5. Absence of self attested photograph and signatures of the candidate at the appropriate places in the Application Form.
6. Tampering of any kind in the Application Form and/or the supporting document

NOTE: If at any stage it is found that the applicant is not eligible for admission in a course under University rules, his/her candidature will automatically stand cancelled. ***It will be the responsibility of candidate to go through rules. Please note that thorough checking of Application Form, Minimum Eligibility requirements, Original documents in support of Academic Certificates, Categories claimed will be done only at the time of Interview*** (if called for the same). At that stage also the candidature of the applicant will stand cancelled, if he/she does not fulfill the requirements of admission.

11. Submission of Application Form

Forms complete in all respect must be submitted to the following on or before the April, 28, 2012 personally or by Registered post / Speed post to HOD or Convener, DPGC of the Concerned Department.

In no case applications shall be entertained after the above date is over.

12. Dispatch Of Admit Card

Admission Card bearing Roll No. and Venue of the test Centre, for appearing in the Test will be sent by concerned HOD/ Convener, DPGC, by post to the Mailing address of the candidate in stamped (Rs.25/-) envelope (To be submitted by the applicant, with Application Form). University shall not be responsible for any delay in communication caused due to wrong/incomplete address given by the candidate or any delay/loss in postal transit. If a candidate does not receive the Admit Card or any communication a week before the date of the Test, he/she should contact the respective Head of the departments on Phone or in person.

Important: The candidate should carefully examine the Admit Card and all the entries made therein. In case of any discrepancy the candidate should inform the Center Superintendent immediately.

DUPLICATE ADMIT CARD: The applicant can obtain duplicate admit card (if required) from the Head of the department of concerned subject, Dr. H.S. Gour university, Sagar. Duplicate Admit Card may be issued on request from Head of the Departments or Superintend (Examination Center) on production of copy of bank Challan, identity proof and a self attested photograph identical to that pasted on application form.

Other Information

- (i). In all matters relating to M.Phil. / Ph.D. Entrance Test and admission to respective Courses, the decision of the University shall be final.
- (ii). Candidate must remain in close/regular contact to the **university Website: www.dhgsu.ac.in** where latest updated information will be displayed.
