

INSTRUCTIONS TO VENDORS

1. Vendors such as suppliers, Fabricators, Manufacturers, Service Contractors may apply for registration by furnishing required documents. Vendors ensure that all documents are in chronological order as per Annexure I.
2. Applicant is not permitted to apply in more than one name, including Proprietorship/partnership firms/Companies where he is involved.
3. ASL reserves the right to reject the applications of any applicant for any of the following reasons :-
 - (a) If they/he/she found black-listed in any Govt/Public Sector Organisation.
 - (b) If they/he/she found to have submitted false particulars/fake documents for securing enlistment.
6. Contractors/vendors etc., whose enlistment has been cancelled earlier, will not be considered for empanelment.
7. Contractors/vendors etc. meeting the following mandatory/minimum qualifying criteria need only to apply for empanelment/enlistment etc.
 - (a) The contractor/vendor etc. must be registered under any relevant Indian Law like Factory Act, Company Act etc., which is applicable.
 - (b) It is desirable that the contractor/vendor have experience of providing services/supplying goods in relevant/similar line for at least three years.
 - (c) The Contractor/Vendor etc. must have Sales Tax Registration No./Service Tax Registration No./Separate PF Code No./Permanent Account No. (PAN), whichever is applicable. The applicant to submit all relevant documents alongwith the application.
 - (d) The contractors/vendor etc must comply with the statutory procedure as laid down in the Vendor Registration Form.
8. The applicant shall mention clearly the category and group to which he/they may be considered for empanelment. Based on the value of job, experience and turnover, as submitted and verified, the applicants will be enlisted under relevant category and group as per norms.
9. Applicants are required to complete all parts of the Vendor Registration Form and all information requested therein. Where the answer is a statement of fact it must be accurate and supported by documentary evidence where required. Where it is a statement of opinion, it must be both true and reasonable. It is the Vendor's responsibility to answer question with such clarity that will enable the committee to interpret the responses appropriately.

10. ASL reserves the right to verify all statements of the applicants and inspect applicant's establishment to evaluate their capacity to execute contract works. ASL reserves the exclusive right and absolute discretion to call for tenders for any specialized job or otherwise it deems fit, even during the validity of the empanelment period.

11. The registration process may consist of a multiphase evaluation, establishment visit for inspection, verification of documents/information.

12. ASL reserves the exclusive right to reject any or all the applications with or without assigning any reason whatsoever.

13. Registration shall be for the purpose of inclusion of applicant's name in the list of registered vendors to ASL for purchase of goods and services.

14. **Additional Category enhancement.** Vendors can apply for additional category inclusion by submitting necessary documents. After scrutiny of documents and evaluation, vendors will be informed about inclusion and panel updated accordingly.

15. **Registration Fee.** Non-Refundable Fee of Rs. 100/- is to be paid through Demand Draft of any nationalized Bank issued in favour of "**The Director, Advanced Systems Laboratory, Hyderabad**", payable at Hyderabad. The Cheque/Money Order will NOT be accepted in any condition. Registration Fee once paid shall not be refunded in case of non acceptance of application for any reason at any stage of processing.

16. The vendors who are previously applied for registration and not in receipt of registration letter from ASL prior to release of this notice are also required to apply.

17. This invitation for registration of vendors shall remain open till **31 May 2011**. Any application received thereafter shall not be entertained.

18.
