**General Information and Guidelines**

1. Application for Provisional registration for Ph.D nursing degree, registration can be submitted on prescribed proforma, accompanied by requisite fee can be submitted to the University at any time of the year.
2. The University will hold an entrance exam for Ph.D Nursing Programme usually in the month of January and July of each year.
3. The successful candidates will be required to submit their application performa through their Supervisor(S) for regular registration to Ph.D Nursing Programme along with the requisite fee and document supporting the application.
4. The candidate should be registered with Baba Farid University of Health Sciences, Faridkot and if not already registered, he/she should do so by producing migration certificate from the previous University, where he/she was registered earlier
5. On receipt of application for registration. Ph.D. Nursing degree along with the requisite fee Rs 5000- the University authorities will send the case of the candidate (if found fit), to the Application Screening Committee, hereinafter ASC, as specified in the concerned Ordinances.
6. The candidate for Ph.D Registration shall present his/her proposed research topic before the ASC on the date and place given by the University.
7. When the committee members in the ASC meeting, find the application and topic for research for the Ph.D degree to be a fit case, shall recommend the same to be sent to the Research Degree Committee (RDC) as provided for in the concerned ordinances.
8. That the candidate will make available the 12(Twelve) copies of Synopsis along with CD-ROM to be taken up for discussion in the RDC meeting.

9. That the RDC may accept or reject the synopsis or it may suggest modifications in the synopsis and reconsider the modified synopsis in the next RDC meeting.
10. That when the synopsis is approved (as such or after necessary modifications), in the RDC will send the case for Ph.D. registration to the Faculty of Nursing Sciences with a detailed note about the research proposal etc. along with a CD-ROM of the Synopsis (to be provided by the candidate) to the University.
11. That the candidate will submit 30(Thirty) copies of his/her approved synopsis along with CD-ROM of his/her approved synopsis through the RDC to the University.
12. That the Faculty of Nursing Sciences will take the final decision about the Ph.D. registration.
13. That during the period of registration for Ph.D. Nursing the candidate will pay all the specified dues from time to time, as applicable, to the University.
14. That the candidate will have to submit his/her half yearly progress reports during the period of registration for Ph.D. degree through the Supervisor's to the RDC committee on or before 15<sup>th</sup> June and 15<sup>th</sup> Dec. of every year.
15. That the candidate will have to present his/her research progress tool presentation, try out/pilot study, findings in the form of a Seminar every year in the month of March in front of RDC along with their Supervisor and Co-Supervisor.
16. A pre-submission seminar will be delivered in front of RDC and audience by the research scholar before submission of his/her thesis for Ph.D. Nursing degree.
17. A summary report of research project for Ph.D. degree will be submitted to the University before submission of thesis for processing appointments of examiners for evaluation of the Ph.D. thesis.
18. The research scholar can seek guidance for preparing half yearly reports, pre-submission report, thesis etc from the forthcoming booklet of this University.
19. The research scholar will submit his/her thesis, as specified in the Ordinances, at the end of his/her registration period for Ph.D. degree.

## **Doctor of Philosophy in Nursing (Ph.D.Nursing)**

### **1. Qualification and Institutional Requirements**

- 1.1 The Ph.D Degree will be instituted in all nursing subjects wherever recognized postgraduate qualifications in nursing subjects are awarded by the Baba Farid University of Health Sciences, Faridkot.
- 1.2 A person is eligible for registration of the award of the Doctor in Philosophy in Nursing if he/she is working in an organization/ institution / teaching department and whose supervisor is working within the jurisdiction of this university.
- 1.3 Registration and award of the Ph.D. degree will be available only upon completion of Post Graduate quantification M.Sc Nursing degree in any Nursing Speciality.
- 1.4 The candidate shall pursue research work at Institute where facilities for advanced research are available for all types of basic and advanced investigative procedures and the institute is adequately equipped and well staffed.

### **2. Eligibility**

The following categories of candidates shall be eligible for registration for research leading to the award of Ph.D. degree from the Faculty of Nursing Sciences of this University provided they are not pursuing any other full time course/studies.

- 2.1 A person holding a recognized post-graduate degree M.Sc Nursing in any Specialty of nursing from this university or any other recognized university with minimum of 55% marks in first attempt.
- 2.2 A person holding a postgraduate degree M.Sc Nursing with 55% marks or equivalent grade from a foreign University deemed equivalent to M.Sc. Nursing degree of this University.
- 2.3 A person working in an organization /institution or an affiliated college of this university fulfilling eligibility conditions at sr. No. 2.1 and 2.2 whose supervisor /guide is working within the jurisdiction of this university.
- 2.4 A permanent teacher of this University or in an affiliated college fulfilling the eligibility conditions as at Sr. No. 2.1 & 2.2 and whose Supervisor/Guide is working within the jurisdiction of this University can

be allowed registration as a part time candidate. Such candidates will pursue his/her research project under supervision of his/her supervisor/co-supervisor's place of work for a period of at least one year. The suggested place of research work should offer a specialized research facility in which the candidate's research topic lies is registered.

### 3. Enrolment/Registration

3.1 Application for registration for Ph.D Nursing on the prescribed form with the registration fee of Rs 5000/- in the form of demand draft in favour of Registrar Baba Farid University of Health Sciences, Faridkot shall be submitted through the supervisor to the University. Each application will be scrutinized by the Application Screening Committee (ASC). ASC will work under the control of faculty of Nursing sciences. The ASC interview the candidate about the research proposal and assess the suitability of the candidate for registration. If found acceptable, the ASC will recommend the candidate's case to the research Degree Committee (RDC). The regular registered candidate for Ph.D degree will pay to the University annual fee Rs.10,000/-

3.2 The candidate shall be required to make a presentation on the research topic of his/her study(synopsis) in front of following members of Research degree committee(RDC) constituted by the faculty of nursing sciences. The RDC will consist of following members for enrolment in Ph.D. from July 11 onwards.

1. Principal of Nursing College concerned (at present Nodal Centre) will be chairman.
2. Proposed supervisor of the candidate.
3. Co-supervisor
4. Prof. & Head of Deptt. of concerned subject from the constituent concerned affiliated colleges of the University
5. One subject experts to be nominated by Dean faculty of Nursing.
6. Two Assoc. assistant Professors from concerned college to be nominated by Dean faculty of Nursing
7. Two Profs. nominated by Vice-Chancellor
8. All Professor of the College concerned constituent College (at present Nodal Centre)
9. Members of College Ethical Committee of Research Projects, Thesis etc.
10. All Faculty members of the Department concerned through which Ph.D registration is applied for.
11. Statistician

**Note:** As Ph.D Nursing has been Started first time in the University and there are no separate nursing departments for example ( Medical Surgical Nsg. Pead Nsg. Community Health Nsg etc) existing in the present nursing colleges till the time the university college of Nursing will be the Nodel centre for Ph.D Nursing, because it is the constituent college of Baba Farid University of Health Sciences, Faridkot for one year (July 11 to July 12)

3.3 The RDC may accept or reject the synopsis on the basis of presentation by the candidate. The RDC may also suggest changes in the synopsis and reconsider the modified proposal. The decision of RDC will be final.

3.4 The Ph.D Enrolment Registration. Candidate, through his/her supervisor co-supervisor will have submitted with his application form alongwith requisite fee Rs.10,000 - per annum. A synopsis containing the following

- i) The title of the subject of research statement of the problem
- ii) The brief review of the literature and justification of research proposal.
- iii) An outline of the proposed research project of the subject.
- iv) References/Bibliography.

A candidate may modify the scheme of his/her research subject with the approval of the faculty of Nursing Sciences within one year from the date of registration.

4. The RDC while recommending the registration of the candidate for consideration of the Faculty of Nursing Sciences will send:

- i) A detailed note about the suitability of the topic as also the methodology proposed by the candidate. The note will also include the names of the faculty members present at the meeting, the duration of discussion and final outcome.
- ii) The supervisor will also be required to give specific comments including feasibility report on the synopsis submitted by the candidate.
- iii) Upon receipt of a positive recommendation about the candidate from RDC through the Board of studies, Faculty of Nursing Sciences will take a final decision towards the registration of the candidates for the Ph.D degree.

## 5. Appointment of the Supervisor(s)

The appointment of supervisor co-supervisor will be as per the following norms:-

- 5.1 Normally there will be one supervisor for each candidate.
- 5.2 A supervisor will not supervise the work of more than Five scholars at a time including Baba Farid University of Health Sciences and other universities.
- 5.3 Following shall be criteria for appointment of supervisor/co-supervisor.
  - A) The supervisor shall have Ph.D degree and 10 years teaching experience and research experience after obtaining his/her recognized M.Sc(N) degree. He/She should be scholar of eminence in the field concerned and should also have published work
  - B) For co-supervisor Ph.D degree and 8 years teaching experience and research experience should be after obtaining his/her recognized MSc (N) degree. He/She should be scholar of eminence in the field concerned and should also have published work.
  - C) Eligible Post Graduate Teachers(Non-Ph.D )having postgraduate qualification with 10 years teaching experience after post graduation may be appointed supervisor and co-supervisor.
  - D) The maximum age of the supervisor will be 67 years

A co-supervisor may be appointed in special cases such as :

- a) If the field of the candidate is such that it requires substantial interdisciplinary input from two or more disciplines.
- b) If the candidate is working at a place other than of his supervisor, a co supervisor from the place of candidates work may be appointed provided that he/she should be scholar of eminence.

The supervisory duties of the co-supervisor shall be the same as that of supervisor.

A co-supervisor will also not supervise the work of more than five scholars at a time.

## **6. Requirements during the period of Registration**

The candidate would be required to document and show the progress during the period of registration for Ph.D. degree.

- 6.1 The candidate for Ph.D. will submit to RDC his/her progress report after every six months duly recommended by his/her supervisors. On non receipt of progress report a fine of Rs. 500 - may be charged from the candidate for every delayed progress report or as decided by University authority

- 6.2 On non-receipt of progress reports or on submission of irregular reports or unsatisfactory reports from the supervisors about the work of the candidate, matter shall be reported by the RDC and Dean, Faculty of Nursing Sciences for necessary action.
  - 6.3 In the event of differences arising between the candidate and his supervisor, a reference shall be made to the Dean, Faculty of Nursing Sciences who may decide the dispute himself or refer it to some other competent person or body for the expert advice. Vice Chancellor may resolve the dispute himself
  - 6.4 Every candidate registered for Ph.D. degree shall present his/her findings on the research project in the form of a seminar every year in the in front of RDC. where other faculty members of the college may also attend. The supervisor shall make the necessary arrangement for the seminar. A detailed report by the supervisor through RDC on the seminar shall be sent to the Faculty of Nursing Sciences. The candidate shall be required to include in his/her thesis any suggestions put forth during the seminar in consultation with his supervisor.
7. **Duration of Research for Ph.D & Submission of Thesis**
- 7.1 A full time Ph.D Nursing candidate can submit his/her for Ph.D not earlier than three year of registration.
  - 7.2 A Part time Ph.D Nursing candidate can submit his thesis for Ph.D. not earlier than four years of registration.
  - 7.3 Thesis for Ph.D. degree will have to be submitted up to a maximum period of five years from the date of registration.
  - 7.4 The Dean, Faculty of Nursing Sciences and Ph.D committee, on the application of the candidate, recommended by the supervisors and forwarded by the RDC may extend this period by one year. While recommending the candidate's application for extension in period for submission of thesis, the progress already made by the candidates will be kept in the view.
  - 7.5 On a similar application, the Vice-Chancellor after considering the recommendation of the Dean, Faculty of Nursing Sciences may further condone the delay in submission of Ph.D. thesis up to one year in very special circumstances.
  - 7.6 Rs.5000/- will be charged as fee for each extension for submission of thesis.

- 7.7 The registration of the candidate will automatically stand cancelled after he/she has availed the extensions allowed by the Dean, Faculty of Nursing Sciences and Vice-Chancellor for submission of Ph.D. thesis.
- 7.8 At the end of requisite period of registration, if the candidate fails to submit his/her thesis, the progress of his/her research work would be submitted to a special review by the RDC by his/her supervisor. If it is found that the progress of work has been unsatisfactory, the RDC may recommend cancellation of registration of the candidate to the Faculty of Nursing Sciences.

### 8 Thesis

- 8.1 Every candidate shall be required to inform the office of Dean, Faculty of Nursing Sciences through his supervisors that he/she intends to submit his/her thesis for Ph.D. in about three months time.
- 8.2 The candidate shall not be permitted to submit the thesis for the degree unless his/her supervisors is satisfied that the thesis presented is worthy of consideration for the award of the Ph.D. degree. In case of an adverse report by the supervisor, the candidate can make a representation through the Faculty of Nursing Sciences to the Vice-Chancellor.
- 8.3 A thesis to be presented by the candidate for the Ph.D. Degree must be a piece of research work characterized either by the discovery of new facts by a fresh interpretation of facts or theories or should consist of applied work. It should depict the candidate's capacity of critical examination, analytical judgment and the art of lucid presentation.
- 8.4 He/She shall be required to submit copies of a detailed summary/broad line of his/her thesis so that these reports could be sent to the examiners for obtaining their acceptance to act as examiners to evaluate the Ph.D. thesis. The office on receipt of intimation from the examiners shall take up the matter of appointment of examiners.
- 8.5 The thesis should be neatly printed or typewritten or published in candidates own name. It should be accompanied by a certificate from the supervisor to the effect that the thesis is worthy of submission for the Ph.D. Degree.
- 8.6 On completion of the research work, the candidate shall submit four copies of his thesis along with the fees of Rs.5000/-. The candidate shall also submit five copies of abstract which will depict the following:-
- a) How far his thesis embodies the result of his/her own research or observations.

- b) In what respect his/her research has contributed in the advancement of the subject.
- c) These revelations shall have to be countersigned by the supervisor and the co-supervisors.

**9. Appointment of Examiner of Ph.D. Thesis**

- 9.1 The thesis for Ph.D. shall be referred to two external examiners for evaluation selected by the Vice-Chancellor from a panel consisting of at least five names in the relevant specialization. The list has to be submitted by the RDC concerned in consultation with the supervisor of the candidate providing the following information about each examiner.
  - a) Name of the Examiner
  - b) Academic status
  - c) Postal Address
  - d) Area of specialization
- 9.2 When the consent of the examiner is being sought for, the availability of the examiners for the conduct of viva-voce examination at a time and place to be decided by the Vice-Chancellor be also ascertained.
- 9.3 The examiners shall be free to seek clarification on any matter from the candidate's supervisor through the Registrar of the University.
- 9.4 Each examiner shall be given one month's time for evaluation of the thesis. In case of delay, the examiner may be reminded telegraphically. After the expiry of a period of two months, if no report is received, the next examiner shall be appointed. If in due course, the report is received from the first examiner, the report shall not be considered.
- 9.5 The examiners should also submit the University their critical evaluation, comments and suggestion on the Ph.D. thesis.
- 9.6 The Examiners individually may recommend one of the following:
  - (i) That the Ph.D. degree be awarded to the candidate.
  - (ii) That the candidate be allowed to re-submit the thesis in a revised form on the lines suggested by the examiners.
  - (iii) That the thesis be rejected.
- 9.7 If both the examiners recommend the candidate for the award of the degree, the Academic Council of the University will propose to the Board of Management that the Ph.D. degree may be awarded to the candidate.

- 9.8 In case, the examiners make recommendations for revision/modification of thesis, the candidate shall be required to do so before his/her case is processed further. The candidate required to re-submit his/her thesis after revision/modification must do so within one year from the date of supply of comments of the examiners to him by the University. Extension for the re-submission time may be granted by the Vice-Chancellor on recommendation of the Ph.D committee. A re-submitted thesis will be examined by the examiners who had recommended the revision/modification.
- 9.9 The candidate required to re-submit his/her thesis after revision will be recharged a fee of Rs.10,000/-.
- 9.10 In case one examiner recommends the award of degree and the other examiner rejects the thesis for the award of the degree, the thesis shall be referred to a third examiner to be appointed by the Vice-Chancellor from the original panel of examiners. The third examiner appointed to evaluate thesis in such cases shall not be informed of the recommendations of the first two examiners. This procedure shall also be followed if the examiner who suggested the revision/modifications rejects the revised thesis.



**10. Reports of Ph.D. Thesis and Oral/Viva-Voce Examination**

- 10.1 The Registrar/Controller of Examinations will personally open the reports on Ph.D. thesis only when they have been received by the University from both the external examiners.
- 10.2 When both the reports of the examiners are positive, the case will be put up to the Vice-Chancellor for conduct of Oral/Viva-voce examination of the candidate on the date and place to be decided by the Vice-Chancellor.
- 10.3 The viva-voce examination of the candidate will be arranged by the University.
- 10.4 The viva-voce examination should preferably be conducted by both external examiners. If it is to be conducted by one external examiner (If permitted by Vice-Chancellor) the other external examiner of the candidate may send in his/her set of questions to be asked from the candidate by the external examiner conducting the viva-voce examination.
- 10.5 When both the external examiners are unable to conduct the viva-voce examination, in that case a set of question would be obtained from them by the Registrar/Controller of Examinations and then the viva-voce examination may be conducted by another examiner to be appointed by the Vice-Chancellor. This examiner shall ask the question sent by the external examiner and evaluate the candidate.
- 10.6 The viva-voce examination of the candidate may be made public to the entire or limited faculty of the college by the Vice chancellor.
- 10.7 The report about the performance of the candidate in the viva-voce examination shall be recorded by the external examiners only.

**11. Award of Ph.D. Degree**

- 11.1 If both the external examiners have approved the award of the degree in their report based on the thesis and the viva-voce examination, then Academic Council will consider these reports and will propose to the Board of Management for the award of the Ph.D. degree to the candidate.
- 11.2 Even if a thesis is approved by both the examiners without any revision or modifications, then the award of the Ph.D. degree after viva-voce examination shall be determined three months after the submission of Ph.D. thesis.

11.3 The Registrar/Controller of Examinations of University shall publish the result.

**12. Publication of Thesis Research Work**

If a successful candidate wishes to publish his/her research work of Ph.D. thesis in original or revised form and wishes to mention the fact that his/her work was awarded, the Ph.D. degree by the University, he/she shall have to seek prior written permission from the University.

**13. Supply of Reports to the candidates**


The reports of the examiners may be supplied to the candidate and the supervisor after the publication of the result.

**14. General Control**

The Ph.D Committee shall exercise disciplinary and general control over the research candidates and their work.

Supervisor through the RDC concerned shall also direct the candidate to pay the dues/fees to the University from time to time as required under the instructions issued by the University.
