EVALUATION

Students are assessed by a combination of examination and course work. They are evaluated on a 10 point grading system, using Cumulative Grade Point System. The core courses carry 4 credits and 100 marks each, while elective courses may carry credits varying from 1 to 4. The minimum credits required for the successful completion of the course is 202, the maximum being 226.

A core subject/4 credit course is assessed on the basis of the following : End Semester Examination (50 M*) + Internal Examination (15 M) + Project work including Viva (25 M) + Attendance (5 M) + Contribution & Class participation (5 M) = 100 M *M = Marks

GRADING SCHEME

The performance at the end of each semester is indicated by the Grade Point Average (GPA) calculated as mentioned below. Also, at the end of the final semester the Cumulative Grade Point Average (CGPA) is calculated based on the same formula.

MOOT COURT COMPETITIONS:

The students of NUALS are known for their excellence in moot court competitions, with many prestigious awards to their names. Apart from their participation in national and international moot court competitions, NUALS has also hosted and conducted the following competitions, with the active involvement of the student body at all stages;

SURANA & SURANA NATIONAL TRIAL ADVOCACY COMPETITION:

The Surana & Surana National Trial Advocacy Competition, a prestigious competition, is annually hosted by NUALS in association with Surana and Surana International Attorneys, Chennai. The Batch of 2016 has enthusiastically taken part in organizing and volunteering for the competition every year.

MARITIME MOOT COURT COMPETITION

The 1st National Maritime Moot Court competition was organized in 2014 by NUALS. The competition explores the frontiers of maritime law, a highly specialized branch of law. The aim of the competition was to expose law students to the national and international aspects of maritime law and foster in them a deeper understanding of the complex issues involved therein. The forum of the competition was the International Tribunal for the Law of the Sea (ITLOS). Judging by the overwhelming response and participation last year, this competition is all set to become an annual fixture in the NUALS calendar.





CULTURAL, LITERARY AND DEBATE INITIATIVES:

NUALS believes in encouraging students to pursue academics, as well as Co-curricular & Extra-curricular activities, so as to ensure well-rounded development of the students. As a result, the following literary and cultural initiatives have been taken;

CULTURAL FEST- NAALAM:

The annual cultural festival of NUALS, Naalam is an initiative of the Student's Council of NUALS. Since its inception in 2010, Naalam has established itself as a coveted platform for college students to showcase their talents. The participants include students from renowned Universities across the country, who take part in events including dance, music, fashion show, literary events and personality competitions.

ALTUS DISPUTATIO:

The flagship concern of the Debate Forum of NUALS, Altus Disputatio is a much-awaited, national-level debate competition held on an annual basis. With a unique format christened "The Devil's Cross", this competition is attended by the best debaters of the country from noted universities. Spanning three grueling days and testing the intellectual limits of the speakers and adjudicators, this is one of the country's biggest debates in terms of prizemoney. The trophy for the best debater was instituted by the late Justice V.R. Krishna lyer, former Judge of the Supreme Court and a heavyweight in the legal arena. The latest edition of the competition, held in 2014, was organized by the Batch of 2016 and its success speaks for the formidable organizing skills and literary acumen of the batch.

HUES: MAGAZINE 2013-14:

Hues, the cultural magazine published by NUALS for the academic year 2013-14, was a student-oriented initiative. Encouraging submissions in English as well as regional languages, it served as a creative outlet for the students of the University.





SOCIAL WORK:

Apart from imparting admirable legal education, the University encourages students to give back to the community as well. The Batch of 2016 has been involved in two such social work programs initiated by the University. These are separate from the various benefit programs which are organized by the Centres of the University and other individual initiatives, which are numerous.

PIL CAMP:

Each year, the Legal Aid Clinic at NUALS undertakes a Legal Aid Program as one of the requirements of the Public Interest Litigation course. These programs are an attempt on the part of the University and its students to increase legal awareness, the target audience being the rural population. The one-day event is generally held in a rural taluk and comprises seminars, interactive sessions and surveys on relevant social issues. The Batch of 2016 undertook a trip to the district of Idukki, which has a predominantly tribal population. The issues of domestic violence, rights of consumers and consumer protection and the Right to Information Act were dealt with exhaustively during this camp.

RESEARCH CENTRE ACTIVITIES




