Common Entrance Test :-

A Common Entrance Test shall be conducted by department of Medical Education Govt. of M.P for admission in to N.R.I. quota seats of M.B.B.S./B.D.S. course in Govt. Autonomous Medical Colleges & Govt. Dental College of State of Madhya Pradesh.

Eligibility to appear in the Common Entrance Test :-

- 1- **Candidate should be Himself/ Herself NRI/OCI OR Children of NRI/OCI. For proof of NRI :- NRI certificate of current year issued from Indian Embassy must be submitted.(Sponsorship from NRI/OCI relatives other than Father/ Mother shall not be considered)**
- 2- The candidates of Unreserved Category should have passed with minimum 50% of aggregate marks in qualifying examination of 12th Standard (10+2 stream) in Physics, Chemistry & Biology / Biotechnology Subject or equivalent examination thereof and also should have passed Physics, Chemistry & Biology / Biotechnology Subject separately.

The candidates of Reserved Category(ST/SC/OBC) should have passed with minimum 40% of aggregate marks in qualifying examination of 12th Standard (10+2 stream) in Physics, Chemistry & Biology/ Biotechnology Subject or equivalent examination thereof and also should have passed Physics, Chemistry & Biology / Biotechnology Subject separately.
- 3- Candidates of Un-Reserved Category as well as Reserved Category should have passed English as a language at 12th Standard exam.

The proof / certificate of passing of qualifying examination of 12th Standard (10+2 stream) must give particulars of the subject and also the percentage of marks obtained/grade awarded in the examination.

Grades must indicate equivalent Percentage of Marks.

- 4- Candidates who have appeared in the qualifying examination of 12th Standard (10+2 stream) in Physics, Chemistry & Biology/ Biotechnology Subject or equivalent examination thereof, can also apply ,but they will have to produce proof of passing the qualifying examination with minimum 50% of aggregate marks in Physics, Chemistry & Biology / Biotechnology Subjects in case of candidates of Un-Reserved Category and with minimum

40% of aggregate marks in Physics, Chemistry & Biology / Biotechnology Subjects in case of candidates of Reserved Category (ST/SC/OBC) at the time of counseling.

Candidates of Reserved as well as Un-Reserved Category shall also produce proof of passing English as a language at 12th Standard exam and will also submit proof of passing Physics, Chemistry & Biology / Biotechnology Subject separately at the time of counseling .

- 5 - The candidates, who have passed their examination from outside India, will have to produce equivalent certificate from Association of Indian Universities, New Delhi. at the time of counseling, otherwise his/her candidature will not be considered.
- 6- The candidate should have attained 17 years of age as on 31st Dec. 2015.
- 7- **The upper age limit of candidates for admission under state NRI quota seats is 25 years as on 31st December of the year of his/her admission in the 1st year MBBS/BDS course.**
Further provided that this upper age limit shall be relaxed by a period of 5(Five) years for the Candidates of Scheduled Caste/ Scheduled Tribe/ Other Backward Classes.

Note:- All the certificates submitted shall be in English.

8. Date& Time of Common Entrance Test :-

The detailed programme of Common Entrance Test will be declared by Dean, M.G.M. Medical College Indore, Madhya Pradesh and will be displayed in www.mgmmcindore.org who is authorized to conduct Common Entrance Test by Govt. of Madhya Pradesh. The detailed programme of Common Entrance Test shall also be displayed on the website of Directorate of Medical Education. www.medicaleducation.mp.gov.in

9. Merit list of Common Entrance Test :-

The candidate will have to secure minimum 50 % marks for U.R. Category candidates & 40% marks for reserved(ST/SC/OBC) category candidates.

Category wise merit lists of Qualified (Successful) candidates, on the basis of marks obtained in the Common Entrance Test shall be prepared.

10. Security deposit & Fees:

- I **Seat allotment shall be done only after deposition of demand draft for Security deposit of US \$ 3000 (Three thousand U.S. dollar) or equivalent in Indian rupees issued by Nationalized Bank in favour of Director Medical Education Madhya Pradesh Bhopal payable at Bhopal, by the candidate.**
In case if the candidate does not take admission on the allotted seat in the allotted Medical College, his / her security deposit will not be refunded.
 - II **Security deposit shall also be non refundable for candidates who do not complete the course after taking admission on the allotted seat.**
 - III **Security deposit shall be refunded back without any interest to the candidate after completion of the MBBS/BDS course, by the respective institution.**
 - IV **At the time of admission candidate has to deposit following fees in the form of Demand Draft of Nationalized Bank or through Internet banking :-**
 - (a) Tuition fees is US\$ 15,000 (Fifteen Thousand US\$) per year or equivalent Indian Rupees.
 - (b) Hostel fee Rs. 15000/- (Fifteen Thousand) per year or equivalent US\$.
 - (c) Caution Money US\$ 3000 (Three Thousand) or equivalent Indian Rupees (Same amount will be refunded in Indian Rupees after completion of course).
 - (d) Student fund US \$ 1500 (One thousand five hundred US\$.) or equivalent in Indian rupees.
 - (e) Other fee as per rule of concerned university/ college. Candidate has to deposit fee at the time of admission and all fees is to be paid in one installment every year as per rule in the concerned college.
 - (f) If the duration of MBBS course is extended due to failing in any of the university examination or due to any other reason. the candidate shall be liable to pay extra fees for extended duration of the course.
 - (g) No any type of exemption in fees shall be permitted to NRI Candidate.
- 11. Counselling (Scrutiny of Original Documents & Seat Allotment)**
Detailed schedule of counseling shall be declared by Directorate of Medical education Madhya Pradesh, Bhopal(M.P.)

Scrutiny of Original Documents

Candidate has to bring his/ her all Original Documents and the desired Affidavit on stamp paper by Notary at the time of Counseling for verification & to ascertain his/ her Eligibility by the Scrutiny Committee. (List of documents as per scrutiny form attached as (Annexure-1)

Candidates should also bring two sets of photocopies of all the relevant documents & 30 (Thirty) copies of colored photographs of the candidate of the similar type as affixed in the Common Entrance Test.

12. Seat Allotment.

- (a) Allotment of seats through counseling will be done based on Category-wise merit list prepared on the basis of marks obtained in Common Entrance Test, after verification of original documents, of eligible candidates.
- (b) Category wise separate merit lists of NRI candidates who are themselves Domicile / Bonafide resident of MP State or Children of Parents who are Domicile / Bonafide resident of MP State and of NRI candidates who are not Domicile/ Bonafide resident of MP State shall be prepared.
- (c) Preference in seat allotment shall be given to NRI candidates who are themselves Domicile / Bonafide resident of MP State or Children of Parents who are Domicile / Bonafide resident of MP State. Counseling & Seat allotment will be done for Domicile / Bonafide resident of Madhya Pradesh State Candidates only in the first round of Counseling.

(Note- The Candidate must be a bonafide resident of Madhya Pradesh for purpose of domicile status, in compliance with the notification no. C-3-7-2013-3-1 dated 25/09/2014 issued by M.P. Govt. GAD Deptt. Concerned individual will be considered as bonafide resident of M.P. on the basis of self signed, self attested declaration given on a non stamp paper in his/her own handwriting/typed declaration/affidavit on the prescribed proforma. (Annexure-2).

The verification of the fact stated in the document submitted by the candidate taking admission on the basis of self attested declaration forms/affidavit by the competent authority (Tehsildar/Upper Tehsildar/Nayab Tehsildar) will be ensured by the concerned Dean/Principal.

If such enquiry proves that admission has been taken by providing incorrect information than the action will be taken to cancel such certificate and as per the Indian Panel Code and existing provision of law, legal action will be taken against concerned candidate and admission will be cancelled. Such candidate have to deposit the sum of rupees equal to the seat leaving bond i.e. Rs. 20.00 lacs(Twenty

lacs) in the account of concerned autonomous college. The original documents will then be returned to the candidate.

- (d) In case of seats remaining vacant in UR category after allotment to NRI Candidates who are Domicile/ Bonafide residents of Madhya Pradesh State, these seats shall be made available to the eligible NRI candidates who are not domicile /Bonafide resident of Madhya Pradesh State according to merit list in the second round of counseling.
- (e) Reserved category seats (ST/SC/OBC) shall be allotted only to the reserved category candidates (ST/SC/OBC) of Madhya Pradesh State as per merit list on submission of valid permanent caste certificate issued by competent authority of Madhya Pradesh Govt. during first round of counseling.
- (f) Reserved category candidates(OBC) will have to submit income certificate of 2014-15 issued by Tehsildar / Naib Tehsildar at the time of scrutiny, Or, submit a self signed self attested income certificate in prescribed income declaration proforma (Annexure-3) as per M.P. Govt. G.A.D. department letter no. C/3-7/2013-3-one Bhopal dated 25-9-2014 to decide creamy layer status.
- (g) Reserved category (ST/SC/OBC) NRI candidates of States other than M,P. shall be considered in UR category.

Seats remaining vacant, after counselling for NRI Seats, will be reverted back as per the existing reservation criteria. Seats reserved for ST/SC/OBC Categories shall not be converted in to UR category, and these seats shall be added to Madhya Pradesh State open seats, in their respective category only, counseling for which shall be held and notified separately. The candidate will have to deposit Rs.10000/- (Rupees Ten thousand) towards counseling charges, at the time of counseling.

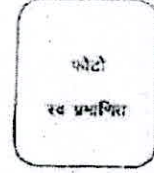
