After receiving the assent from the His Excellency, Governor of Nagaland, the establishment of the university was notified in Government Gazette vide notification number Law/Act-10/2006 on dated 18th September 2006. The Distance Education Council, New Delhi has recognised the Global Open University, Nagaland vide letter DEC/GOU/NGL/Recog/2008/8685 dated 2nd June 2008. The Global Open University, Nagaland is empowered to award degree as specified under section 22 of the UGC Act, 1956 vide UGC Letter No. 4-2/2007 (CPP-1) dated 26th February 2008. His Excellency, Governor of Nagaland, is Chancellor of the University. The Global Open University, Nagaland is administered by a Governing Council. The Council has distinguished dignitaries among its members having representatives of Nagaland Government, an educationist of repute and an academician nominated by Pro-Chancellor. The Academic Council is responsible for all academic matters.

The Global Open University, Nagaland has interim headquarters at Dimapur (Nagaland). The University Campus has well-equipped physical and academic infrastructure with workshop, laboratories, computer lab and library. The Act of The Global Open University, Nagaland permits the university to offer programmes

through online and distance education mode across the country and abroad. 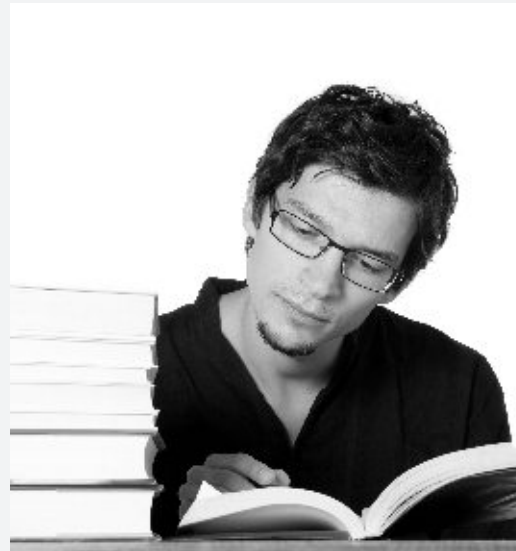

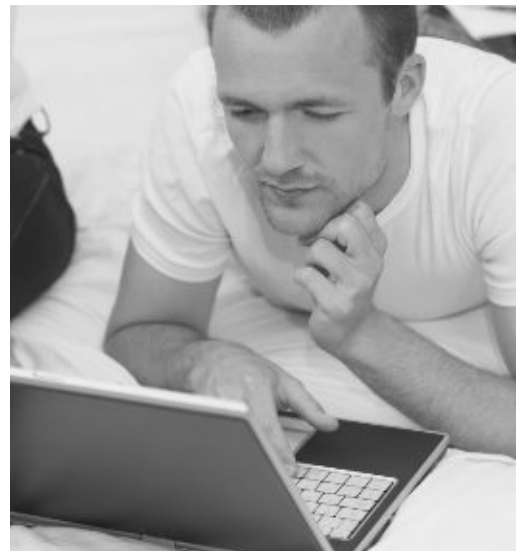

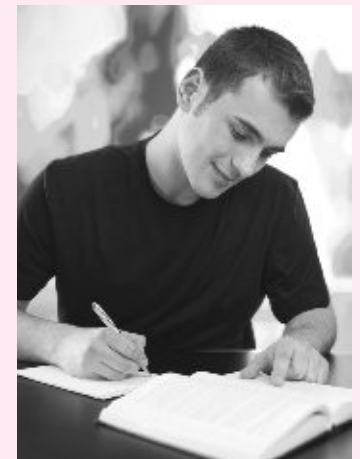

ADMISSION POLICIES

ADMISSION

The goal of the University is to select students whose academic background, work experience, leadership abilities, communication skills meet the demands of the Professional Degree Programs. These individuals must be able to benefit from, as well as, contribute to the educational programs. Intelligent ethical, articulate and active individuals are encouraged to pursue this program.

BASIC ELIGIBILITY

The Basic eligibility for Admission to M.Phil., M. Tech. & M.S. Course is Post Graduate Degree. Post Graduate Degree means a candidate who has successfully completed a 2 year University Degree program.

The Basic eligibility for Admission to PG Course is Bachelor Degree. Bachelor Degree means a candidate who has successfully completed a 3 year University Degree Program. Note: Students having 2 years Bachelor Degree has to do a bridge course.



TECHNICAL REQUIREMENTS

The Technology Enabled Learning(TeL) programs require a reliable internet connection. ADSL or Broadband connections are recommended. FOREIGN STUDENTS

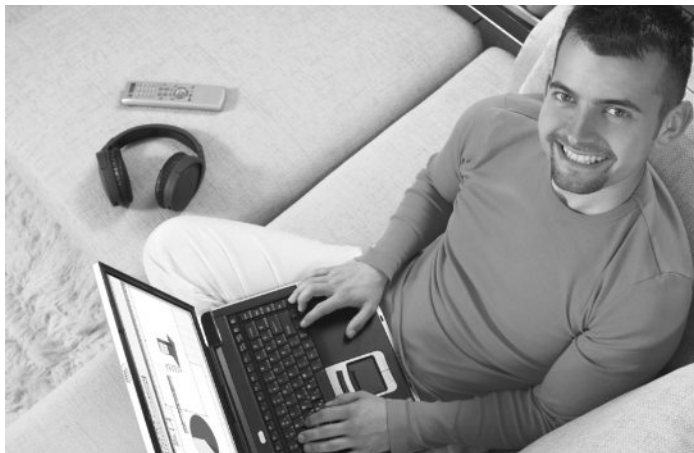

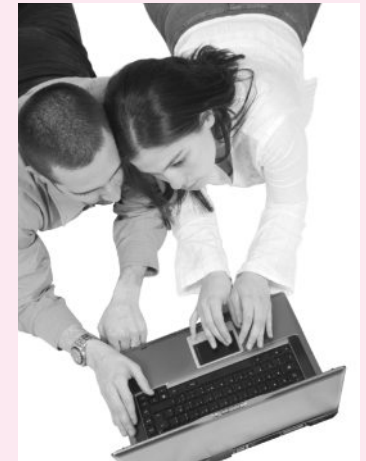

You may reapply for award consideration in the next academic year / semester.

Deadline & Notification of Award

Academic Session: Priority will be given to those students applying on or before October 30 for the Academic Session. Scholarship recipients will receive an award letter during the month of December. Applications received after this date will only be considered if funds are still available.

Calendar Session: Priority will be given to those students applying on or before April 30 for the Calendar Session. Scholarship recipients will receive an award letter during the month of June. Applications received after this date will only be considered if funds are still available. Incomplete Applications will not be considered

RULES & REGULATIONS

ENROLLMENT NUMBER

Enrolment Number will be assigned to every candidate on admission. The enrolment number will remain same for the total duration of course. Students should invariably quote their enrolment number in all their correspondence with the TGOU, to facilitate prompt response from the University. Letters/e-mail received without the enrolment number will not be entertained.

IDENTITY CARD

Every student will be issued an identity card which should be carried by them at all times while being at the e-Learning Point and produce it when requested.

The identity card issued to a student is e-Learning Point specific. Students have the privilege to utilize the facilities provided to them in the particular e-Learning Point they have got the admission, and will not be valid in any other e-Learning Point.



In case of loss of Identity Card, a duplicate shall be issued at a specified cost, subject to a written request from the student, duly signed by e-Learning Point authorities. The Identity Card is valid only for the duration of programme the student has sought the admission for. Students are advised to keep the ID card carefully, as it provides proof of their bonafide student status.

PAYMENT OF FEE

It is the responsibility of the students to pay their fees within the deadline as communicated by the University through website www.tgouonline.com. The fee has to be paid before the start of the year as per the deadlines. The e-Learning Point shall not make any individual correspondence for fee submission.

In case the student doesn't pay the fee within the deadline late fee will be charged as per decision of the University. In case the student doesn't pay the fee during the above mentioned period, the student will be deemed to have dropped the course & will not be allowed to continue the programme.

The fee is non-refundable and cannot be adjusted for subsequent years.

Students must check the University website www.tgouonline.com for important instructions & deadlines. The mode of payment shall be ONLY Demand Draft in favour of **“The Global Open University, Nagaland”**, payable at **Dimapur**.

TGOU & Apex Foundation will not be liable for fee paid in cash to the e-Learning Point.

Other University fees such as statement of marks Rs 150/-,

provisional certificate Rs. 500/-, degree certificate Rs. 750/-, consolidated mark sheet Rs. 500/-, change of name Rs. 250/-, change of centre Rs. 1000/-, any duplicate certificate Rs. 1000/-, rank certificate Rs. 250/-, late submission of dissertation/ project per month Rs. 600/-, Duplicate Identity Card Rs. 250/-. Examination Fee Rs. 250/- per Subject, Lateral Entry Fees is Rs. 2000/- per year and Entrance Test Fee for Open University System (OUS) Programs is Rs. 1500/-.

LIBRARY

Online Campus provides Virtual Library with links to articles, publications, informative sites, news items and reviews.

Every e-Learning Point has its own Library. Only valid Library cardholders will be eligible to use the library facility.

The student can get issued one book/magazine at a time for one week. If the book/magazine is overdue, a fine of Rs. 10/- per day will be charged.

In case of loss or damage to the book, student will have to bear the expense of the book or replace the same.

In case of loss of library card, duplicate card (on cost) will be issued on the submission of a written request to the e-Learning Point authorities. Library card will be valid only for the regular duration of the programme. Library card will be valid for only the e-Learning Point in which the student has got admission.

CENTRE TRANSFER POLICY

e-Learning Point transfer will be allowed only to other cities in case of situations, like transfer of job, medical grounds etc. and that too will be with the approval of existing e-Learning Point, Online Campus & the University. The student is not permitted to take transfer to any other University/College or other TGOU affiliated institutions. Transfer from one e-Learning Point to another for foreign nationals is not permitted.

Centre Transfer will be allowed only if the course is being conducted at the destination e-Learning Point. The student

will agree to the batch timings as suggested by the destination e-Learning Point.

If the student takes transfer to any other e-Learning Point without the approval of University, his/her admission will be cancelled & the fee will stand forfeited.

Centre Transfer within the same city or within the radius of 10 Kms is not allowed under normal circumstances.

Mid session transfer is not permitted. In case of Centre Transfer the student has to fill a Centre Migration Form and obtain a No-objection Certificate from the existing e-Learning Point & destination e-Learning Point.

EVALUATION AND GRADING

Evaluations are conceived, developed and administered on a rigorous and fair basis to bring out the best in students and prepare them for challenging careers. A student's performance is based on:

Continuous evaluation carrying 30% weightage on the final score. Continuous evaluation is done through online assignments and practicals.

University examinations conducted at the examination Centres and evaluated by the University, carrying 70% weightage on the final score.

In each subject, a student should secure at least consolidated 50% marks in continuous evaluation and University examinations to be declared pass.

Based on the student's performance, the following grading system will be adopted:

A = Excellent (+80%)

B = Very Good (+70%)

C = Good (+60%)

D = Satisfactory (+50%)

E = Failure

If a student fails to clear any of the papers, he/she has to re-appear for the relevant paper by applying to the University through the examination form along with relevant fees, within the due date specified by the University.

ONLINE ON DEMAND EXAMINATIONS

Students are required to appear for online on-demand examination for each subject of the curriculum. Online examinations are conducted through authorised eLearning points in more than 100 cities across India. TGOU reserves the right to add or delete any examination centre. The online examinations provide students with the flexibility of appearing for any paper, as per their convenience during the one month examination period. Examination will be held normally in the month of July and January each year as the case may be. The TGOU reserves the right to hold examination during any other period as may be decided by the University.

Examinations will be held on all days including Sundays and other Holidays to enable the candidates who are employed to attend the examinations.

International Students can be administered the online examination through Approved Examination Centres, Embassy offices / Reputed Companies / Universities. Detailed instructions regarding the online Examination will be sent to students before the exams and also upload on the website. Students who wish to appear for examinations at any overseas test centers are required to contact the Indian Embassy/High Commission/Consulate Officials/Approved Examiner and obtain their consent to supervise the examinations. Such students are required to mail the consent along with the Examination Form and the specified examination fee.

The necessary consent from the Indian Embassy/High Commission/Consulate Officials/Approved Examiner for appearing in the examinations should be obtained by the student.



AWARD OF DEGREE/DIPLOMA/CERTIFICATE

DMC shall be issued only to students passing all the subjects of the yearly examination.

The Degree/Diploma/Certificate will be awarded to the student only if he/she has acquired a pass grade in all the term-end examinations within the maximum duration of the course.

The degree/diploma is processed after one year of successful completion of course but a provisional degree certificate can be obtained by the student by depositing requisite fee along with copy of all Detail Marks Card through a request form. The student of final year of Degree/Diploma course will have to submit the Degree Issuance Application along with the requisite fee as prescribed by the University at the time of Re-Registration for the Final Year.

In case the student does not clear all the term-end examinations in the maximum time as mentioned in the course details he/she will not be awarded any Degree/ Diploma/Certificate. In such case no refund of fee will be given.

DISCIPLINE

Students are required to follow the decorum while attending the programme.

Students will not be allowed to enter into the e-Learning Point without permission of the e-Learning Point authorities, once they have completed the programme or have been expelled.

TGOU & Online Campus has the discretion to close any e-Learning Point and in such cases the concerned student should contact the Online Campus for re- allocation to a new e-Learning Point.

The students are advised to read the following guidelines carefully before completing the Application Forms.

- a. Attested photocopies of certificates of all your undergraduate, graduate studies and professional qualification and address proof shall be enclosed with the Application Forms for Admission.
- b. Original Certificates should not be sent.

MODE OF REMITTANCE

- a. Fee for the program is to be remitted along with the Application Forms for Admission at the time of enrollment. Payments should be made through A/c payee crossed demand draft of any commercial bank, drawn in favor of **“The Global Open University, Nagaland”** payable at **“Dimapur”**. The fee can also be remitted through credit card by holders of VISA and Master Card. The employees of the e-Learning Point are not authorized to accept cash payments from the students. Also the employees of the Online Campus are not authorized to swipe their personal credit cards to pay on behalf of the students.
- b. Students making the payment through credit card are required to complete the relevant column in the Application Form for Admission.

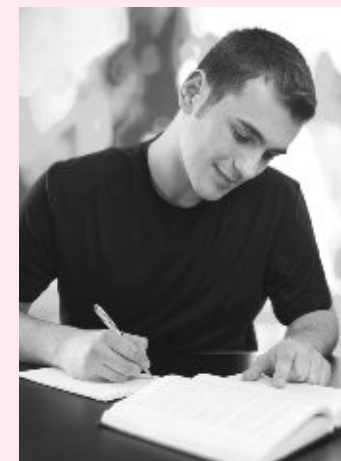

- c. Attested Copies of Certificates of Date of Birth, X Class and Educational Qualifications/Mark Sheets.
- d. Students have to produce attested photocopies of any one of the following documents as address proof at the time of admission; Latest telephone bill, latest electricity bill, latest property tax bill, voter ID Card issued by any authorized body with seal.
