## 1. RESEARCH PROMOTION SCHEME (RPS)

## 1.1 Objectives:

This scheme Promotes Research in identified thrust areas of in Technical Education. RPS is aimed to create research ambience in the institutes by promoting research in engineering sciences and innovations in established and newer technologies; and to generate Master's and Doctoral degree candidates to augment the quality of faculty and research personnel in the country.

The objective of this scheme is to create and update the research capabilities of the faculty members of the various Technical Institutes. The proposal should include a specific project theme with a clear statement of the objectives, details of equipments and other research facilities proposed to be acquired and the expected deliverables from the project.

- AICTE approved Technical Institutions / University Departments with relevant PG programme.
- Full time regular faculty with research experience and publications.
- The preliminary research facilities should be available in the institute.
- One proposal from one PI (Principal Investigator) will be sanctioned at any point of time within the duration of project.
- 1.3 Limit of Funding: Total funding of Rs.25 Lakh
- **1.4 Beneficiary:** In the last five years numbers of Institutes benefited are tabulated in Table 1.

## 2. MODERNISATION AND REMOVAL OF OBSOLESCENCE (MODROBS)

## 2.1 Objectives:

The main objective of the Scheme of Modernization and Removal of Obsolescence is to provide financial support to institutions to equip their laboratories/workshops with modern equipment/infrastructure facilities, keeping in view rapid advancements in technology. It also supports new innovations in Class Room and Laboratory / Teaching Technology, development of Lab Instructional Material and appropriate Technology to ensure that the practical work and project work to be carried out by students is contemporary and suited to the needs of the Industry.

- AICTE approved Technical Institutions / University Departments with at least 10 years of existence.
- For self financing/Institutes, maximum 3 proposals per institute per year including sanctioned but not completed would be considered.
- For Govt. /Govt. aided Institutes, maximum 10 proposals per institute per year including sanctioned but not completed would be considered.
- 2.3 Limit of Funding: Total funding of Rs.20 Lakh
- **2.4 Beneficiary:** In the last five years numbers of Institutes benefited are tabulated in Table 2.

## 3. FACULTY DEVELOPMENT PROGRAMME (FDP)

#### 3.1 Objectives:

The Faculty Development Programme (FDP) intends to provide financial assistance to facilitate upgradation of knowledge, enrichment and up gradation of pedagogy educational technology, motivation, communication skills, management and other relevant issues to keep pace with the changing scenario in Technical Education. It not only promotes the professional practices relevant to technical education but also motivates the faculty to achieve competitive teaching and learning environment, thus channelizing development with respect to academic qualifications and personal matters.

- AICTE approved Institutions / University Departments in existence of minimum 5
  years, imparting technical education are entitled for the grant.
- Coordinator must be full time regular faculty with adequate experience in teaching and research with publications.
- Maximum 5 proposals per institute per year including sanctioned but not completed would be considered.
- The each FDP programme beneficiary shall have at least 50 participants on National level and International level.
- 3.3 Limit of Funding: Total funding of Rs.7 Lakh
- **3.4 Beneficiary:** In the last five years numbers of Institutes benefited are tabulated in Table 3.

The Scheme intends to promote high standards in Technical Education by way of extending opportunities to the academicians and working professionals by providing a forum for sharing their knowledge, experiences, innovations and inventions.

- The institute must be an AICTE approved Institutes/AICTE approved University Department.
- Coordinator must be full time regular faculty with adequate experience in teaching and research with publications.
- Maximum two proposals per institute per year including sanctioned but not completed would be considered.
- **4.3 Limit of Funding:** Rs. 2 Lakh for National Conference and Rs. 3 Lakh for International Conference
- **4.4 Beneficiary:** In the last five years numbers of Institutes benefited are tabulated in Table 4.
