# **One Year LL.M. Programme**

## **LL.M. CURRICULUM AND PROGRAMME**

NLSIU offers One-Year LL.M. Degree programme in two distinct branches of specialization namely:

- a. Business Laws, and
- b. Human Rights Laws.

Candidates have to appear in CLAT-PG exam for the purpose of taking admission in this course. NLSIU offers this course to top rank holders of CLAT-PG exam.

## **COURSE STRUCTURE**

The LL.M. programme is based on the Trimester system. In each trimester four courses are offered for study. In all these subjects, national and international dimensions are properly highlighted. During the third and last trimester, students are required to submit a dissertation. Students are also required to undergo mandatory internships during the academic break between second and third trimester and also participate in the weekly seminar presentations in which students present their research papers which is also evaluated.

## LL.M. INTAKE

At present the total intake of the batch is 50 of which 35 are pursuing LL.M. in Business Laws and 15 are pursuing LL.M. in Human Rights. Students pursuing LL.M. have completed their LL.B. from various universities and colleges including West Bengal National University of Juridical Science, National Law Institute University, Bhopal, National Law University Odisha, Dr. Ram Manohar Lohiya National Law University, Chanakya National Law University, Delhi University, Banaras Hindu University, Aligarh Muslim University, Amity University, Government Law College Mumbai, University of Pune, Indraprastha University, Lucknow University.

## LIBRARY

The Library has all the state of the art gadgets with Wi-Fi internet connection and highly modernized Audio- Visual equipments with tele-conferencing

facility. Special arrangements have also been made for the physically challenged persons to access the library.

## IT SERVICES

The National Law School strives to provide for a high quality, efficient and secure infrastructure that would enhance the productivity of all its users. All class rooms are equipped with computers and projectors. To further enhance the quality of classroom experience “E-Class” equipments are installed in the classrooms. A good video conferencing facility is also provided to enable students to benefit from faculty located in other places within and outside India.

## THE HALLS OF RESIDENCE



# PROCEDURE

---

- 1. The NLS Recruitment Coordination Committee (RCC) and placement officer will work with recruiters to streamline the placement process. Student profiles and other relevant details are shared with the recruiters.*
- 2. The recruiters may conduct Pre-Placement Talks to give in-depth information about the organisation, including the roles and profiles being offered. The presentation is followed by a Q&A session, where students interact with company officials to get a better understanding of the organisation and potential roles.*
- 3. In response to job descriptions given by the recruiters, applications are invited and resumes of interested applicants are shared with the recruiters through the placement office. A detailed resume is submitted by the students as part of the application process.*
- 4. On the basis of students' applications, recruiters are required to send a list of shortlisted students to the RCC at least a week prior to their final placement interviews. Recruiters conduct their selection process which typically comprises CV based shortlisting, group discussions and interviews.*
- 5. The recruiter can make an offer to the student after the final interview. For an offer to be valid, it should include details of role, location, remuneration, and other relevant terms and conditions required by the candidate to make a decision.*

### Reaching NLSIU

1. Through a Bus: One of the city's largest bus stands is located right opposite the City Railway Station called as "Majestic" Bus Stand. The buses that come to Nagarbhavi are: 235, 235B, 235C, 235F and 43 (Pushpak) [From Platform 19A]. Alternatively, one can catch a bus to Vijay Nagar and then an auto rickshaw to NLSIU.
