**Result for Document verification or Interview & Document Verification ( as applicable ) for the Para Medical Categories of CEN 04/2014 - On the basis of written examination held on 08.02.2015 for Para Medical Categories, the following candidates have provisionally qualified for being called for Document Verification OR Interview & Document verification as applicable. Document Verification will be done for verification of original certificates in support of their educational qualification, age, community and their original call letter/admit card, photograph, signature etc. The candidates are directed to report for the above said **Document Verification ( for Cat 01,02,03,05&19,06,07,08 and 20 ) from 31.07.2017 to 03.08.2017 OR Interview & Document Verification ( for Cat 11 and 12 ) on 08.08.2017 at 08.30 Hrs in RRB office, Divisional Office Compound, Western Railway, Mumbai Central, Mumbai - 400 008 as per schedule indicated below. Candidates are being individually intimated. However, RRB will not be responsible for the postal delay or wrong delivery, if any. The Roll Nos. are given below.****

**The additional 30% extra candidates called as standby candidates will be considered for empanelment only if there is a shortfall in empanelment from the main list.**

**Candidates who fail to attend the Document Verification on the scheduled date for Category No.01,02,03,05&19,06,07,08 and 20 shall be given second chance for Document Verification (DV) on Block Date as per schedule indicated in the result . But such candidates strictly should have a valid reason with supporting document for not attending the DV on their scheduled date. Candidature of candidates who do not report even in second chance for Document Verification shall be cancelled for the above post.**

**For candidates called for interview for Category No. 11 & 12 on 08.08.2017 , Document verification will be held on the same day. For such candidates no second chance for Interview and Document verification will be given. Candidature of such candidates who do not report for Interview and Document Verification for Category No. 11 & 12 on 08.08.2017 shall be cancelled.**

Call letters are being sent to the Candidates by Registered Post. In case of non-receipt of intimation by post, candidates are hereby directed to report for Document Verification OR Interview and Document Verification as applicable on the scheduled date with call letters of Written test.

Candidates are required to bring all their original marksheets and certificates. Candidates must produce their original matriculation certificate for date of birth verification and education qualification marksheets, certificates and diploma/degree as applicable from a recognised Board/Institute as notified in the notification on the day of Interview/Document Verification without fail. If any candidate does not receive the call letter, the candidate should attend the Interview/Document Verification strictly on the specified date indicated in Railway Recruitment Board Mumbai along with all documents.

The candidates belonging to SC/ST & OBC should bring their original caste certificate in prescribed format. In case of OBC candidates the caste certificate should be current and not more than one year old and should have clause of Non-Creamy Layer.

SC/ST/OBC candidates must also ensure that the address mentioned in their caste certificates tally with the entries of permanent address made by them in their application forms.

Candidates should also bring their original call letter of Written test along with the call letter for Document Verification OR Interview and Document Verification as applicable and the photocopies of all the original certificates and documents. Any candidate coming for the verification without complete documents will be asked to return and their candidature is liable to be cancelled without any further notice .

In case of variation in name/father's name/initial etc. necessary affidavit from Notary to be submitted stating that the name as filled in application and that appearing in all certificates refers to the same person and submitted at the time of verification.

Candidates are required to submit 3 copies of their recent passport size photographs.

Candidature of those candidates who fail to produce the original certificates in support of their date of birth/qualification/community in proper format/NOC(No Objection Certificate) on the day of verification is liable to be cancelled without any further notice.

The onus of proving the eligibility for the post concerned and the genuineness of the other averments made in the initial application shall rest with the candidates. Their candidature would be purely provisional and would be liable to be cancelled, at any stage of recruitment or thereafter, in case any inconsistency is noticed at the stage of Interview/Document Verification or later.
