



# Terms and Conditions for the "Up To 50% Discount for Citi PremierMiles Cardholders"

## 1. Program Scope

The program "Discount up to 50%" applies in Hochiminh and Hanoi for all Citibank Vietnam PremierMiles World Master cards issued by Citibank, N.A., - Ho Chi Minh City Branch and Citibank, N.A. – Hanoi Branch (collectively referred to as "Citibank")

## 2. Program Period

#### 5. Eligible Customer:

Citi PremierMiles World Master Card holder issued by Citibank Vietnam issued by Citibank with the first 8 digits starting with either **53394800** or **53394899** ("Eligible Credit Card")

#### 6. Eligible Transaction

- Transactions eligible for the program is a retail transaction using Eligible Credit Card at POS machine at Merchant's premises and must have POS bill containing the following information for identification: Card Issuing Bank Name, Card Holder Name, Merchant Name, and Transaction Amount
- Customer will receive discount on the bill immediately if the transaction is eligible.
- Customer is not allowed to split bill on one table

#### 7. Other Terms and Conditions:

- Maximum discount offered per bill would be 2 Million VND and customers are not allowed to split to multiple bill per table
