beyond this period, a late fine of Rs. 250/- (including GST) per day will be calculated. However in such a case the Institute may cancel the registration of the student in his/her programme if no valid justifiable ground is established for the delay.

The above fee includes the cost of course material, two 'NICMAR T-Shirts', one tie and safety gear.

## **HOSTEL AND LIVING EXPENSES**

Hostel accommodation is available at Pune, Hyderabad (Shamirpet), Goa (Farmagudi) and Delhi NCR (Bahadurgarh). Girl students granted admissions are housed separately. All students have to abide by the Code of Conduct issued by the Institute.

Hostel allotment will be done on programme-wise merit basis.

### **Pune Campus**

The campus has four hostels which altogether provide 1139 single occupancy rooms for boys and 194 shared occupancy for girl students. The details are as follows:

In case, students cannot be accommodated in the campus hostel facility, they may be accommodated in a hostel close proximity to the campus.

Food package charge is **Rs. 202/- (Food charges) + Rs. 38/- (GST@18%) = Rs. 240/- per head per day**. The package includes breakfast with tea, buffet lunch, evening snacks with tea and buffet dinner.

The Institute mess facilities are run by a contractor hired by NICMAR under the supervision of the Manager - Premises and Services (P&S). The Manager according to the suggestion of Students Mess Co-ordinator prepares menu on weekly basis.

### **Hyderabad Campus at Shamirpet**

This campus has three hostels, *Udyath* and *Jagrath* for boys and *Dhanashri* for girls, which altogether provide 560 shared occupancy rooms for boys and 136 shared occupancy rooms for girl students.

Shared occupancy in campus : Rs. 3,600 per month

Single occupancy in a two bedded room for girls (if available) : Rs. 5,500 per month

Food package charge is **Rs. 186/- (Food charges) + Rs. 34/- (GST@18%) = Rs. 220/- per head per day**. The package includes breakfast with tea, buffet lunch, evening snacks with tea and buffet dinner.

All programmes at Hyderabad (Shamirpet) campus are fully residential and students have to compulsorily reside in the hostels.

## Goa Campus at Farmagudi

This campus has total four hostels, which altogether provide 242 shared occupancies for boys and girl students. Hostel has the capacity to occupy 50 students in Ponda Commerce Center Hostel, 80 students in Pearl Hostel, 80 students in Main Campus Building at Farmagudi and 32 students at Sadashiv Apartment Hostel.

Food package charge is **Rs. 168/- (Food charges) + Rs. 32/- (GST@18%) = Rs. 200/- per head per day**. The package includes breakfast with tea, buffet lunch, evening snacks with tea and buffet dinner.

## Delhi NCR Campus at Bahadurgarh

This campus has total three hostels, which altogether provide 300 single and shared occupancies separately for boys and girl students. The hostels are available in the campus itself. Hostel has the capacity to occupy 210 students in Arya Hostel, 70 students in Shanaya Hostel and 20 students in Aayra Hostel.

Single occupancy in campus : Rs. 4,500 per month  
Shared occupancy in campus : Rs. 3,600 per month  
Single occupancy in a two bedded room for girls (if available) : Rs. 5,500 per month

Food package charge is **Rs. 168/- (Food charges) + Rs. 32/- (GST@18%) = Rs. 200/- per head per day**. The package includes breakfast with tea, buffet lunch, evening snacks with tea and buffet dinner.

## Payment Schedule

Hostel and mess fees are payable term-wise within 7 days of the commencement of the term. In case of any delay, a fine of Rs. 75/- (including GST) per day will be payable for the first 7 days, after which, the fine will be Rs. 125/- (including GST) per day. The hostel and mess fees once paid are

non-refundable or non-transferable. Mess facility is mandatory for all students staying in NICMAR hostels.

Typically, the total living expenses including hostel, mess and any other expenses at Pune/ Hyderabad (Shamirpet)/Goa (Farmagudi)/Delhi NCR (Bahadurgarh) are approximately Rs. 12,000/- to Rs. 14,000/- per month.
