He/ She should have knowledge to identify and do the necessary trouble shooting of the rig equipment and tools and have knowledge of HSE and statutory rules & regulations as per Mines Act, OISD rules, etc. He/ She should be capable of identifying well control situation and overall management of the well site crew. The candidate should also have good inter-disciplinary skills and should be conversant about mud chemicals and maintenance of mud property.
