### **General Information**

- 1. Applications are invited from eligible Indian citizen. Mere eligibility will not entitle any candidate for being called for interview.

- 3. The envelope containing the CV in the prescribed format along with supporting documents in support of age, caste certificate, qualifications and experiences, superscribing "Application for the post of ......", whichever is applied should be clearly mentioned, must reach the office of Director, National Institute of Pharmaceutical Education and Research (NIPER), B.S.10/1, Sector 10, Jankipuram Extension, Sitapur Road, Lucknow 226 031, by registered / speed post till 04.07.2017. All the attested copies of mark sheets/certificates etc shall be produced at the time of interview.
- 4. The date for determining the age limit/experience/qualifications shall be the closing date prescribed for receipt of applications.
- 5. Applications for each post should be submitted separately.
- 6. The Institute will NOT be responsible for non-receipt of application(s) within the stipulated date due to any postal delay/ loss of application / document sent in transit. Late applications may not be considered.
- 7. On the recommendation of the screening / selection committee, the competent authority may relax age limit/ experience/ qualification on recommendation of the Committee. However, there is no age limit for Departmental candidates.
