Brahmaputra Valley Fertilizer Corporation Ltd, a CPSE under the Ministry of Chemicals & Fertilizers was created by demerger from Hindustan Fertilizer Corporation Ltd. The company operates two Ammonia-Urea plants at Namrup in the Upper Assam District of Dibrugarh with a capacity to produce 5.5 lakh MT of urea per annum. The Govt. of India has recently sanctioned a new Ammonia-Urea Project to be set up at the existing plant site of BVFCL under PPP mode. The project shall have raw material from the nearby oil/gas fields of M/s. Oil India Ltd and targeted to produce 8.64 lakh MT of Urea per annum. The company invites applications from Indian nationals for the following post:

- 6) Candidates employed in Govt. Department/Public Sector Undertaking/ Autonomous bodies shall either forward their application through proper channel or shall produce "No objection certificate" from their present employer at the time of interview.
