GUIDELINES FOR INTERNATIONAL PROGRAMMES (Faculty)

- Applications called for trainings of 2018-19 slots only
- Faculty from the accredited programmes of the accredited colleges are only eligible.
- Interested faculty can download the application form from ANGRAU website and submit their filled in application with relevant supporting documents and undertaking form clearly indicating preferred training areas and statements of purpose to **the Principal Investigator, IDP and Dean of Agriculture, ANGRAU, Administrative Office Lam, Guntur – 522 034.**
- Statement of purpose should justify the need for training and future course of application.
- Candidate will be considered for only one programme
- Faculty should be below 58 years of age
- 60 percent of the training slots to < 40 years (may be flexible if sufficient number of applicants in the age group are not available)
- 25 percent of the training slots to above 40 and below 50 (may be flexible if sufficient number of applicants in the age group are not available)
- 15 percent of the training slots to above 50 and below 58 years (may be flexible if sufficient number of applicants in the age group are not available)
- Should not have been benefitted under HRD/capacity programme of NAIP
- Trainings should be within the priority areas as mentioned in IDP sanctioned order.
- Publications - Only those published in the last five years with ISSN/ISBN Number. Minimum of two publications in journals with a NAAS rating of 4.0 and above.
- Special consideration to awardees/Gold medals/ Significant contributions/Projects in their field must be given
- The certified worksheet containing details on gender and social status, scores of all the applicants under different parameters should be made available to the Project Implementation Unit (PIU) of the NAHEP along with a one page profile of the shortlisted candidates regarding their academic and other achievements considered for selection and a scanned passport size photograph printed on the right top corner of the page for record
- The candidate should not deviate from the proposed subject and not change the place of work.
- A one-time to-and-fro travel grant will be paid in advance by the University. The final bills need to be submitted on return of the trainee along with copy of vouchers of air travel and original boarding pass to the University.
- In case of the faculty, the initial release will be 80% of the total cost; the remaining 20% would be released / settled on the submission of final bill and final report duly endorsed by the AU.

- The candidate will be entitled for air travel in economy class from the nearest airport to his/her present place of work in India and to the nearest airport to the place of the overseas host institution by the shortest route.
- For domestic and international air travel the AU/ GoI (in case of CAUs)/ICAR (in case of DUs) guidelines shall be applicable.
- Every faculty trainee shall be required to execute a service bond duly accepted on nonjudicial stamp paper as per the AU rules
- It shall be the responsibility of the concerned AU to which the candidate belongs, to recover the bond money from the Candidate and remit the same to the NAHEP.
- In the event of any question, dispute or difference whatsoever arising between the candidate, his/her employer in India and NAHEP out of or relating to award of NAHEP overseas training, the same shall be governed by the laws of India for the time being in force and the rights and liabilities hereunder shall, wherever necessary, be accordingly determined by the appropriate courts in India.
- Medical insurance expenses will be governed by the AU/ICAR rules, as applicable.
- Candidate is entitled for the training only for the duration it is sanctioned for and no application to extend the period of training shall be entertained.
- The trainee should make presentation before the Principal Investigator, IDP, ANGRAU and also should submit the compliance report within a month after completion of programme in prescribed proforma given by ANGRAU.
- The onus of identification / selection of the programme and choice of training to which the candidate has selected lies with the University. The programme a faculty is deputed shall be subjected to the finalization of arrangements with the host (foreign) university. The decision of the University decision shall be final in all matters.
- Last date for submission of application form in the proforma prescribed is 29-01-2019.

Undertaking by Faculty selected for undergoing International training programmes

1. I, Dr./Mr./Ms. _____ working as _____ at Agricultural College, _____, of Acharya N G Ranga Agricultural University have been selected for undergoing International Training under Institutional Development Plan (IDP), ANGRAU at _____ University carefully read and fully understood the guidelines prescribed by NAHEP and shall abide by them.
2. I shall execute a service bond duly accepted on nonjudicial stamp paper as per the AU rules.
3. I shall devote whole time on the chosen area of training during the tenure and will not seek gainful employment elsewhere.
4. I shall not accept any financial assistance from any other source.
5. I fully understand that the service bond may be invoked for violation of any of the terms and conditions.
6. In addition, the service bond may also be invoked in the event of any of the following:
 - i. candidate does not return to India, after training as normally expected
 - ii. takes up a job abroad on completion of the training;
 - iii. candidate fails to complete the training period;
 - iv. Candidate fails to serve his/her parent institution on return after her/his training for a minimum period of three years; any other condition prescribed by the NAHEP from time to time.
7. I hereby solemnly affirm that in the event of the service bond being invoked, I shall be liable to pay back the total expenditure incurred by the NAHEP in deputing the candidate for the international training along with interest on the said amount compounded annually from the date of availing of the grant, at prevailing government rates.
8. I shall submit a joining report duly forwarded by my supervisor to the ANGRAU under intimation to ND, NAHEP immediately on joining the host laboratory (Foreign Institution).

9. I shall submit a completion and deputation report through ANGRAU to the ND, NAHEP within a month of joining in duty after completion of the training in the overseas in the prescribed format
10. I shall be required to make a presentation in the parent institute on joining back in duty and also in the PIU, NAHEP if required to
11. I fully understand that in all the publications made during the training, NAHEP shall be acknowledged prominently for the support through the award of the international training as “the work was executed / carried out under the financial assistance for the international training provided by the Indian Council of Agricultural Research through the National Agricultural Higher Education Project”.
12. I fully understand that due credit shall be given to the NAHEP-ICAR in case any Intellectual Property Rights (IPRs) brought out of the work during or after the training. The Payment of Royalty/IPRs of the resulting publications should be taken care as per the extant GoI guidelines and the ANGRAU should get the benefit out of Patents / Royalty or the individual faculty. Any dispute arising in this regard shall be under jurisdiction of Indian courts and applicable laws of India will be enforced for settling such cases.
