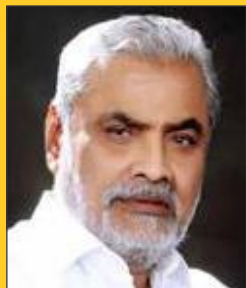

OUR INSTITUTION



Inspite of being gifted with rich cultural heritage, Bidar remain economically and educationally backward since long time .Our founder president Late Sri M. Rampure who had a rare vision, did a yeoman service by realizing this fact and established BVBC, Bidar in the year 1960, with a view to provide educational opportunities to the youth of this area which has resulted in the realization of their educational aspirations. People now don't have to go to places like Hyderabad or Gulbarga for higher education. The fact that he purchased 52 acres of land in 1960 bares ample testimony to his profitic vision.

The college has all the necessary facilities such an ample infrastructure, dedicated teaching faculties , spacious campus with high academic ambeans . All these features have contributed to the college being accredited with "A" grade by NAAC. The college is named after the well known philanthropist Sri. B. V. Bhoomraddi from Gadag.This college has really heralded a new era in the educational history of Bidar city. It is a co-educational college affiliated to Gulbarga university which has granted permanent affiliation in the year 1996. It offers six semester degrees courses in Arts, Science, Commerce and Computer application. In addition to this the college also offers four semester M.Sc course in computer science.

DEGREE COURSES

The college follows non – elitist policies of admission, in keeping with its ideals of education to all and social justice. B.V. Bhoomaraddi College does not share the general perception of B.A. B.Sc. Courses being irrelevant. We value the understanding of the society and cultural process that the social sciences provide when pursued with interest. Each of the combinations offered will give the student a true multidisciplinary perspective into contemporary affairs.

BACHELOR OF SCIENCE:

B. Sc. I Semester

- 1) A candidate who has passed the two year Pre-University examination of Karnataka State or any other examination considered as equivalent is eligible to get admission for first semester of B.Sc. Degree course.
- 2) A Candidate who has passed two years job-oriented P.U. Diploma Examination conducted by Director Vocational Education, Govt. of Karnataka (Excluding the subject in the existing regulations) is also eligible.

Course Study:

- 1) The Maximum period for the completion of course will be of three years.
- 2) The course consists of a combination of three subjects of equal importance and shall also consist of two languages and Compulsory subject such as, Indian Constitution, Environmental Studies and ECA.
- 3) The medium of instruction shall be in English with exception in case of language papers. The medium of examination shall be in English.

PART-II

A candidate has to select any one of the following combinations:

- 1) Chemistry – Botany - Zoology
- 2) Physics – Chemistry - Mathematics
- 3) Physics – Mathematics - Computer Science

BACHELOR OF COMMERCE:**B.Com. I Semester:**

- 1) A candidate who has passed the two year Pre-University examination of Karnataka State or any other examination considered as equivalent is eligible for admission to first semester of B.Com. Degree course.
- 2) A candidate who has passed the two year job-oriented Pre-University Diploma examination conducted by the Directorate Vocational Education Government of Karnataka is eligible for admission.
- 3) A candidate who has passed the Diploma course in commercial practice/secretarial practice examination conducted by the Board of Technical Education, Government of Karnataka is eligible for Third Semester subject to the condition that he/she should pass the subjects prescribed for First and Second Semester of B.Com. Degree Course which he/she has not studied at the said Diploma Course.

BACHELOR OF ARTS:**B. A. I Semester:**

- 2) A Candidate who has passed two-year job oriented Pre-University Diploma examination conducted by the Director of Vocational Education, Government of Karnataka (Excluding the subject in the existing regulations).

BACHELOR OF COMPUTER APPLICATIONS :

Bachelor of Computer Application (B.C.A.) Degree shall extend over a period of Three Years consisting of Six Semester.

Eligibility:

- 1) A candidate who has passed the Two Year Pre-University Examination of Karnataka State OR any other examination considered as equivalent thereto and has studied Mathematics as one of the subjects/PUC Commerce is eligible for admission.
- 2) A candidate who has passed the Two Year Job Oriented Pre-University Diploma examination with Computer Science/Electrical subject conducted by the Directorate of Vocational Education, Government of Karnataka is eligible for admission.
- 3) A candidate who has passed the Diploma in Computer Science Examination conducted by the Board of Technical Education, Government of Karnataka, shall be eligible for admission.

CLAIM OF EXEMPTION

A candidate who keeps terms for I, III and V Semesters will be allowed to keep terms for II, IV and VI Semesters, respectively, subject to the following conditions.

- I) A candidate who passes 50% of Theory and Practical subjects put together of I and II semester examinations (at the end of II Semester) be allowed to keep terms for III Semester
- ii) A candidate who has passed I and II Semester and 50% of Theory and Practical subjects put together of III and IV Semester examinations (at the end of IV Semester) is allowed to keep terms for V Semesters.

M.Sc. in Computer Science

Eligibility:

- 1.1 A candidate who has passed B.Sc. Degree Examination of Gulbarga University Or any other University recognized as equivalent thereto is eligible for Admission to the First Semester of the Course provided he/she has studied the concerned/cognate subject at the B.Sc. degree course with at least 50% of the marks in the concerned/cognate subject and also in aggregate in all the years of the Bachelor degree course. However, SC/ST and Category-I Candidate should have secured at least 45% marks in the concerned/cognate subject and also in aggregate in all the years of the Bachelor's degree course.
- 1.2 A candidate who has passed any of the following Bachelor's degree examination of this University or any other University recognized as equivalent there to shall be eligible for admission.
 - a) B.Sc. with Computer Science/Information Science / Information Technology as one of the optional subjects.
 - b) B.Sc. with Mathematics / Physics / Electronics / Statistics / Instrumentation as one of the optional subject and one year Post – Graduate Diploma in Computer Science or Computer Applications (PGDCS/PGDCA) of Gulbarga University or any other University recognized as equivalent there to.

- c) B.Sc. (Information Science)
- d) Bachelor of Computer Science or Computer Application (BCS/BCA)
- e) Bachelor of Information Science or Information Technology (B.I.Sc./ B.I.T.)
- f) B.E./B.Tech. (all Branches)

COLLEGE REGULATIONS

DISCIPLINE AND DECORUM

1. The date for admission to various classes/course shall be as per University norms.
2. The application forms and other details for admission can be had from the College Office during working hours on all days on payment of Rs.100/-
3. 18% of the total seats in the College are kept reserved for SC/ST students, Nomadic and Semi Nomadic tribes as per Government Order.
4. Fees must be paid by the stipulated date failing which the terms of the defaulters may be cancelled without prior notice.
5. The Government & University may revise the fee structure from time to time & the student shall pay accordingly whenever notified.
6. Students opting to discontinue their studies shall get their admission cancelled immediately by giving application. Failing which they continue to remain on the roll of the College and liable to pay the term fees.
7. Ignorance of notices on the College notice board is no excuse.
8. Attendance is compulsory for all Lectures, Tutorials, Tests, Mid-Term examinations and Practicals as per the University norms. The students failing to keep 75% attendance shall be liable for cancellation of their admission.
9. Every student is required to carry his/her identity card to the College. The card should be shown to any member of the staff Or College official when inquired.
10. Students must cultivate the use of the library. They are expected to spend their free time in the reading room Or referring books in the library section.
11. No student is allowed to take readmission to any of the classes/courses in the College.
12. A student is required to produce an affidavit from the Court in case of any gap in study period.
13. Insubordination, neglect of work, unbecoming language or conduct obscenity in word or deed render a student liable to temporary or permanent dismissal.
14. The campus must be kept clean at all times, avoid littering with waste paper, defacing the walls or desks, damaging College property etc is strictly prohibited
15. Though the College is not responsible for the conduct of its students outside the premises it will take note of any serious misconduct of a student outside the campus.
16. The students admitted to the various classes shall be deemed to have accepted the rules of discipline of the College & they shall be binding on them.
17. Any employee seeking admission to the College must produce in duplicate written permission from his/her employer to do so if he/she hushes up the fact that he/she is employed his/her terms will be cancelled at any time during the academic year & the fee paid will not be refunded.
18. Ragging is totally banned. Any complaints in this regard will be dealt with seriously by the authorities
19. Refund of fee is as per the rules of the University.
20. No Student is allowed to enter the College campus without Uniform.
