#### Note-

- The candidates admitted in Self-Finance Colleges shall deposit their fee in four instalments as already decided by the State Admission and Fee Committee, Haryana.
- As per the letter No. CB-1X/2012/10026 dated 26-7-2012 of Dean of Colleges Dev. Council M.D.U the admission in Colleges of Category 'C' are purely provisional and the condition is reproduced as "The admissions in the colleges against which category 'C' (due to gross deficiencies pointed out in the report with regard to teaching faculty, infrastructure facilities and other support system in terms of norms of NCTE/University/State Govt.) has been mentioned shall be made purely provisional and subject to final decision against whom disciplinary proceedings are pending at the University level. Students shall take admission in these 'C' Category colleges at their own risk and responsibility."
- The 'C' Grade College (affiliated with KU, Kurukshetra) is a deficient college and the admissions in the college are provisional at their risk and responsibility subject to the final decision of the University.
- The detail of College of all the participating Universities is available in the prospectus category wise on website.
- It takes 1-2 days to reconcile the fee with the bank and then the candidate is permitted to fill choices. So the candidates are advised to visit the website after a minimum gap of 1 day. In case the fees is not reconciled, the candidate should Login and complaint Online about this. Don't forget to mention the name, Application no. Bank Branch code, Date of deposit, Transaction ID, Name of bank and amount deposited.
- If required, the website may remain close from 7 PM to 8 PM for regular maintenance.
- The seats meant for Haryana Domiciles, if left unfilled, will be filled up from amongst the applicants of ALL INDIA CATEGORY whose applications have already been received in the University upto the last date of receipt of applications for self financing colleges.
