#### **ORDINANCE NO. 12**

#### FOR

#### **Doctor of Philosophy (Ph.D.)**

#### 1.1 Preamble

The Degree of Doctor of Philosophy (Ph.D.) may be awarded by the University to a registered student on his/her successful completion of the prescribed programme of research offered by the University.

#### **1.2 Structure and the Roles**

Research Studies leading to the award of Doctor of Philosophy (Ph.D.) shall be organised and managed by the following bodies in accordance with their respective roles as specified here under:

#### **1.2.1** Academic Council :

The Research degree programmes of the University shall be in accordance with the Research Policy adopted by the Academic Council subject to the provisions of the Act and the Statutes of the University.

#### 1.2.2 Research Council

There shall be a Research council which, subject to the overall guidance and supervision of the Academic Council, shall be responsible for the Planning, Management, Organisation and Monitoring of research programmes.

The composition of the Research Council shall be as follows :-

- (i) The Vice Chancellor shall be the Chairman of the Research Council.
- (ii) Director/Incharge of Research Cell- Member Secretary

- (iii) Two Members/Experts not below the rank of Professor who are not employees of the University, nominated by the Vice Chancellor.
- (iv) One representative each of the Planning Board and the Academic Council, nominated by the Vice Chancellor.
- (v) One other faculty member of the University including Visiting Faculty appointed on contract or recognised faculty, nominated by Vice Chancellor.
- (vi) Atleast one subject expert not below the rank of Professor of each discipline in which research proposals are to be considered, nominated by Vice Chancellor.
- (vii) The term of the office of the members will be three years from the date of nomination
- (viii) The Research Council shall meet at least twice a year approximately after six months. One third of the total membership shall form the quorum for the meeting.

#### **1.2.3 Board of Studies**

The Boards of Studies, as constituted under the provisions of the Statute, shall operationalize the research degree programmes in the disciplines assigned to the concerned Departments in accordance with the policies and guidelines laid down by the Academic Council and the Research Council.

#### 1.2.4 Research Cell

The University shall constitute a Research Cell, which will look after all the activities related to the research. The Research Cell shall comprise the Director/IC Research along with atleast two supporting staff. All the activities related to research from Admission/Registration to the final evaluation and declaration of the result will be the responsibility of the Research Cell. The cell will work under the Supervision of Director of Academic Coordination.

#### 2 REGISTRATION AND SUPERVISION

2.1 Eligibility

- 2.1.1 The process and schedule of registration shall be prepared and announced by the University in accordance with the guidelines given by the Research Council from time to time.
- 2.1.2 Doctoral students will be admitted through an Entrance Test conducted at the level of University. Students who qualify UGC/NET/CSIR (JRF) Examination/ SLET/GATE/ Teacher fellowship holder or have passed M.Phil programme for Ph.D, will be exempted from the Entrance Test. If number of applicants are limited to number of seats in concerned department, then there will not be entrance test.
- 2.1.3 It shall be followed by an interview to be organized by the School/ Department/ Institution/University as the case may be.
- 2.1.4 At the time of interview, doctoral candidates are expected to discuss their research interest/area.
- 2.1.5 Only the predetermined number of students may be admitted to Ph.D. Programme.
- 2.1.6 While granting admission to students to Ph.D. Programmes, the Department/Institute/School will pay due attention to the National/State Reservation Policy.
- 2.1.7 Any candidate having a Master's Degree in the concerned subject will be eligible to appear in the Entrance Test. However, in the inter disciplinary researches the candidate should have Maters Degree in the Main subject.
- 2.1.8 Provided that research work leading to Ph.D. Degree may be allowed in allied subjects of interdisciplinary nature of the same faculty or of allied faculties. In such cases the candidate may also be permitted to work under one or two co-supervisors, alongwith the supervisor.
- 2.1.9 A Candidate who has been registered shall deposit the prescribed registration fee within a period of one month from the date of issue of registration letter. However under special circumstances extension upto another two months may be given by the Vice Chancellor with late fee of 10% of the registration fee, on the recommendation of the Director/IC Research Cell failing which registration may be cancelled.

The programme fees shall include registration fee late fee (if required) fee for the course work evaluation fee and any other fees prescribed by the University from time to time. Registration fees shall be Rupees five thousand, programme fee Rupees Ten thousand and evaluation fee Rupees five thousand. The registration of a student may be cancelled for any of the following reasons:

- (i) Non-payment of fees;
- (ii) Unsatisfactory 6<sup>th</sup> monthly progress Report;
- (iii) Non-compliance with the provisions of the ordinance;
- (iv) Failure to submit the Dissertation/Thesis within the time limit prescribed;
- 2.1.10 The Research Council may consider requests for re-registration from students whose registration is cancelled on the recommendation of the supervisor and the Director/IC Research Cell.

#### 2.3 Supervision

- 2.3.1 Every student registered for a research degree programme shall be required to pursue the programme under the supervisor and co-supervisor (as the case may be) recognised by the University. Supervisior/co-supervisor for students shall be approved by the Research Council in accordance with their choice from the panel of supervisors recognised by the University.
- 2.3.2 The Research Cell shall recommend to the Research Council, a panel of experts to be recognized as the Research Supervisors who may belong to M.P.Bhoj(Open) University or any other educational institution of state of Madhya Pradesh.
- 2.3.3 An academic with a Ph.D degree in the concerned subject and with at least five years experience of post-doctoral research or PG teaching experience or conducting P.G. Programme in the concerned subject shall be eligible for consideration for recognition as a Research supervisor/Co-supervisor.
- 2.3.4 A Supervisor shall not have, at any giving point of time, more that 8 Ph.D. scholars and 5 M.Phil scholars under him/her.
- 2.3.5 Provision may be made for payment of a suitable honoranium to the supervisor for guiding students registered to M.Phil/Ph.D. Programme.

#### 2.4 Allocation of Supervisor

The allocation of the supervisor for a selected student shall be decided by the Research council.On the application of the candidate and the consent of the superisor.

#### **3 PROGRAMME DESIGN**

#### 3.1 Course Work

After having been admitted, each Ph.D. students shall be required to undertake course work for a minimum period of one semester/6 months. The course work shall be treated as pre Ph.D. preparation and must include a course on Research Methodology which may include quantitative methods and Computer Application as per UGC norms. It may also involve reviewing of published research in the relavant field. If found necessary course work will be carried out by the doctoral candidates within the University.

#### **3.2 Evaluation and Assessment Method**

#### Duration

- 3.2.1 The minimum and maximum time for completing the programme shall be 2 years to 5 years, counted from the date of registration to the programme. The period may be curtailed or extended with the approval of the Vice-Chancellor.
- 3.2.2 If a student fails to submit the dissertation/thesis within the above period, his registration shall be cancelled.
- 3.2.3 Prior to submission of the thesis, the student shall make a pre Ph.D presentation in the University/Department that may be open to all faculty members and research students, for getting feedback and comments, which may be suitably incorporated into the draft thesis under the advice of the supervisor.
- 3.2.4 Ph.D candidates shall publish at least one research paper in a standard journal before the submission of the thesis/monograph for adjudication, and produce evidence for the same in the form of acceptance letter or the reprint. The decision of standard journal shall be taken by research council.
- 3.2.5 The candidate will have to submit three hard copies, two CD's and three copies of summary of the thesis.
- 3.2.6 The thesis produced by the Ph.D student in the institution and submitted to the University shall be evaluated by at least two experts, out of which at least one shall

be from outside the State. The examiners will be appointed by the Vice-Chancellor from a list of 6 experts submitted by the supervisior and approved by the Board of Studies of the subject concerned. The Board of Studies can include more names, if it thinks fit.

- 3.2.7 The examiners will submit their Evaluation Reports to the University individually.
- 3.2.8 On the recommendation of the examiners for the award of Ph.D. degree, an open Viva- Voce examination of the thesis shall be conducted by a panel comprising one of the external examiners, to be nominated by the Vice-Chancellor, and atleast one of the supervisor of the candidate. The Chairman of the Research council or his nominee would be the Chairperson of the panel. The Viva-Voce examination shall be open to all interested participants.
- 3.2.9 In case any examiner suggests certain modifications and re-submission of the thesis, the same should be communicated to the candidate, who will be asked to resubmit the thesis with all the modifications within six months. The research supervisor will ensure that the suggestions of the examiner(s) are adequately addressed before resubmission of the thesis. The modified thesis shall be referred again to the examiner(s) concerned for re-evaluation.
- 3.2.10 If one of the examiners does not recommend the thesis for the award of Ph.D. Degree, the thesis shall be referred to third examiner for evaluation. If the third examiner recommends the thesis for the award of a Ph.D. Degree, the *Viva-Voce* examination shall be organized. However, if third examiner also rejects the thesis, the thesis shall be rejected by the University.

#### 4 AWARD OF Ph.D. DEGREE.

On the recommendation of the External, Internal and Viva-Voce examiners the candidate shall be awarded the Ph.D. degree with the approval of the Vice-Chancellor along with its notification.

#### 5 **REMOVAL OF DIFFICULTIES**

Notwithstanding anything –contained in the above ordinance the Vice Chancellor may take such measures as may be necessary in respect of candidates for M.Phil./Ph.D. who is registered with the University.

#### **6 DEPOSITORY WITH UGC**

- 6.1 Following the successful completion of the evaluation process and announcements of the award of M.Phil/Ph.D the University shall submit a soft copy of M.Phil/Ph.D the thesis to the UGC within a period of thirty days, for hosting the same in INFLIBNET, accessible to all Institutions/Universities.
- 6.2 Along with the Degree, the University shall issue a provisional certificate certifying to the effect that the Degree has been awarded in accordance with the provisions of the Regulations of the UGC.
