2. **Eligibility and Procedure :**

i) Minimum qualifications prescribed for admission to Ph.D. course in all faculties shall be as per Ordinance 1.4. i.e. only M.Phil./LLM or equivalent qualifications (UGC-CSIR) and Ordinance 16.12.

- i) The written component of the entrance test shall carry 80 marks.
- ii) The interview and discussion on the research proposal of the candidate with the Departmental Council / Committee shall constitute **20** marks.
- The minimum qualifying marks to be obtained in the written test would be 50% (40 marks).
- The duration of the written test shall be Two Hours / Two and Half Hours.
- 3. Merely obtaining qualifying marks in the Ph.D. Entrance Test shall not confer any right upon the candidate for his / her registration to the Ph.D. programme. Admission to Ph.D. programme will be subject to the availability of seats / supervisors in the concerned departments.
- 4. Affix with gum three latest attested passport size photographs at the appropriate places (photocopies shall not be accepted.).
