- NOTE: 1). No Admissions shall be made after the stipulated cut off date under any circumstances.
  - 2). Proper care shall be taken while submission of data online pertaining to students admitted, Readmitted, admitted on transfer and no additions will be allowed after submission of data online.

Further, it has been decided that from the academic year 2012-2013, all the readmission cases are to be forwarded to the University for approval. A separate Circular is being issued in this regard. The Principals are requested to ensure the eligibility to the effect that the students seeking readmission/admission on transfer are able to complete the course within the double the duration of the course from the year of their original admission.

I am to state that as per the norms of the University, a regular Principal and required number of staff are essential to carry out the academic activities and every affiliated college is expected to have such regular staff. I am also to state that any college which makes admissions over and above the permitted strength in a course, that course of the college shall be automatically disaffiliated.

It has come to the notice of the University that some of the Principals are giving consent to the candidates coming from other colleges/Universities seeking admission on Transfer into II & III year Degree courses without verifying whether they have studied the same course/combination at parent College/University or the same combination is available at the college, causing embarrassment to the University and hardship to the candidates. The Principals are therefore, requested to thoroughly check the applications for admission on transfer into UG courses in the same course/combination studied by them before giving the consent. In the case of admission on transfer into Commerce courses, the Principal shall ensure that the consent is given for the same course studied by him/her at the parent College/University and offered at the college.

The Principals are requested to strictly adhere to the rules and regulations of admissions.
