JOINING INSTRUCTIONS FOR ADMISSION: SESSION 2014-15

Dear Sir/Madam,

1. You will be glad to know that your son/ward, Master _____

Roll No _____/KP who appeared for interview / medical examination has been provisionally selected for admission to Class VI/IX in this School. <u>Admission is</u> <u>subject to production of relevant documents as required vide paragraph 6 and</u> <u>depositing the fees</u>. Your son has been allotted School No _____, which is to be quoted in all future correspondence with the School.

2. You are requested to pay the following amount of fee for the admission of your son / ward at the time of admission: -

NOTE:

(i) Any increase in fees by the Sainik Schools Society subsequently will be intimated and charged accordingly.

- (ii) In addition to the above fees, an amount of Rs 1,770/- is also payable as supplementary diet charges. <u>Thus total amount payable at the time of</u> <u>admission is Rs 77,248/- for General / Defence Category and Rs 75,748/-</u> <u>for SC / ST category.</u>
- (ii) On receipt of the documents as mentioned in para 6 below, your entitlement for the grant of scholarship will be ascertained and if found eligible, the case for grant of scholarship will be referred to concerned Govt for sanction. The amount of scholarship sanctioned, if any, will be refunded / adjusted against fee dues in the subsequent years of stay of cadet.

3. Please note that the amount is to be paid by Crossed Bank Demand Draft only drawn in favour of <u>PRINCIPAL, SAINIK SCHOOL</u> payable at <u>KAPURTHALA</u>. Cheque/cash will not be accepted.

4. Parents are to provide items as per Part-I of Appendix 'C' of the School Prospectus. The School will provide necessary equipments and clothing (as per Part II of the list after admission) to your son / ward to ensure uniformity in the pattern of clothing and other accessories being used by the students.

5. You are also requested to purchase the text books as per list attached for your son under your own arrangements.

6. All parents are required to submit the following documents duly <u>attested by First</u> <u>Class / Executive Magistrate</u> and completed in all respects, at the time of admission.

ESSENTIAL REQUIREMENT OF DOCUMENTS FOR ALL CANDIDATES

(a) <u>Domicile Certificate</u> – To be signed by the Sub Divisional Magistrate (Civil) of concerned District with one photograph of Cadet duly pasted on it. (In case of Defence Personnel, please bring a certificate from OC of your Unit showing the permanent address of the parent).

(b) <u>Affidavit regarding Rules and Regulations of Sainik Schools Society</u>, Specimen signatures and permanent address of the parents duly attested by First Class/Executive Magistrate as given in Appendix – 'K' of school prospectus to be executed on non-judicial paper worth Rs 25/- or above.

(c) <u>Affidavit regarding Realization of Fees</u> as given in Appendix – 'L' of School prospectus to be executed on non-judicial stamp paper worth Rs 25/- or above.

(d) <u>Proof of Age</u> Date of Birth Certificate from the Registrar, Births & Deaths/Municipality to be produced, in original, for verification with an attested copy.

(e) <u>School Leaving Certificate</u> duly countersigned by the concerned District Education Officer / CBSE / ICSE, as the case may be.

(f) <u>Boys whose parents are Defence Personnel or Ex-Defence Personnel:</u> The date of birth entered in the service documents maintained in the Record Office of the respective services will be submitted. In case of children born after individual's release / retirement from service, the provision of para-6 (d) and above will be applicable.

(g) <u>Indemnity Bond</u> – As per Appendix – 'M' of School prospectus.

(h) <u>Family Details</u> – As per Appendix – 'N' of School prospectus on plain paper along with ten photographs in white shirt of new entrants and a joint photograph of the parents to identify the parents. Blood group should be duly authenticated from a qualified Laboratory.

(j) For Scheduled Caste / Scheduled Tribe Certificate only – Original SC / ST Certificate from competent District authorities.

(k) Affidavit regarding ragging from parent's side as well as student's side as per format attached on non-judicial stamp paper worth Rs 10/- or above.
