





# The Importance of Voting

Now that the campaign season is entering the final weeks, there will be a huge increase in the TV ads, mail pieces and other campaign activity—all meant to persuade voters to vote one way or another. However you may choose to vote, the most important thing is that you do go vote! Not just because so many men and women have given their lives for that very privilege, but also because at every level of government, votes matter.

Our votes will ultimately decide whom we send to Washington to be our voice and look out for our best interests. Some people may think that one vote can't change anything or that your particular vote won't matter. But that's just not true. This year, statewide turnout in the June primary was only 8%! The lowest it has been in decades. Of the 5,462,710 New Jersey residents that are eligible

to vote, only 416,065 cast their ballots. If turnout is anywhere near that low on November 4th for the general election, then you can rest assured that every single vote will make an impact.

This is an important election with so much at stake! Whether it's creating jobs, supporting our firefighters, or any number of other federal issues. there are some pretty big differences between the candidates. And the only way

you can change things or make them better is if you vote. Voting doesn't guarantee that you can make a difference. But if you don't vote then you definitely can't make a difference.

Within this edition of the FMBA Bulletin is a list of those congressional candidates that your FMBA leadership feels will be the best voice of the fire service in Washington DC. We do not take our endorsements lightly.

There is so much at stake in this election. It all starts with you. Your vote can make sure we elect a "fire friendly" congress. Your vote can mean the difference between bringing funding and safe working conditions for firefighters versus continuing to be vilified as we have been in Trenton. 

- Municipal taxes are the smallest part of your property tax bill. Pension reform will not provide meaningful property tax relief for taxpayers in NJ.
- The Firefighters pension is sustainable with the mandated contributions from the members and the Municipalities. Our pension would be fully funded if the Municipalities had not skipped payments.
- Firefighters don't contribute to Social Security, nor do the municipalities on our behalf. Our pensions were established in place of full social security benefits.
- Firefighters contribute 10% of their salaries to their pension and have never missed a payment.
- Firefighters have repeatedly offered to discuss meaningful pension and benefit issues.
- We are taxpayers. We share in the frustration of containing property taxes. NJ residents need to know the facts on the actual costs to taxpayers for the services we provide.
- We already exemplify the "No Pain No Gain" strategy. We have lived up to our end of the pension and benefit reform.



The intention of the bill is to provide for first responders who have become ill as a result of performing the duties of their job. Different incarnations of the bill have been revised and voted on, but none has yet to pass muster with the Governor's office. Many fine lawmakers have supported this bill before and after revisions, and it is the case again in this session. This is a very important bill that will one day become law, and first responders will have some peace of mind that our efforts are recognized.

The committee voted, primarily along party lines, to move the bill out of committee, with amendments, on October 9th, and it is scheduled to be heard by the full Senate on October 23rd.

With this in mind, always wear tour PPE and work safely!

Editors note: as we go to press it was reported that S-264 passed in Senate with a vote of 22-12 and has been received in Assembly and referred to the Assembly Labor Committee.

### **Half-Truths and Lies by Omission**

In September, Governor Christie's Pension and health benefit study commission released the Status Report on the State of New Jersey's existing state and health benefit programs. This report was to focus on the pension and health programs that the state is fiscally responsible for.

Unfortunately, this report both left out and glossed over important information that should have clearly been spelled out to the local taxpayer.

A few facts that should have been included so that all taxpayers could fully understand the pension and benefit issue.

- 1) The state of New Jersey does not pay any pension payments toward any local government employee's pension. The monies for the local government employees pension comes from your municipal tax that is included in your yearly property taxes, more often than not this is the smallest portion of your tax bill.
- 2) Despite years of skipping contributions to the pension system municipalities have to their credit been making the required payments into the system over the past decade.
- 3) Due to the employees continued pension payments over the years and municipalities now contributing full

contributions into the system ,the local government employee retirement system is currently funded at 75%.(includes all municipal employees) This is considered healthy and puts the local government retirement system amongst the top in the country. There is no doubt that with fiscal discipline by all stakeholders our pension system is sustainable and on the way back to the 100% funded level, as it was fifteen years ago.

The most disappointing aspect of the study was the commission's complete ignorance of the current healthcare situation in New Jersey. There is no justification for doing a study on pension and healthcare reform without including the provisions of chapter 78. By omitting the unprecedented emplovee contributions toward healthcare premiums, the commission has put itself in the position of being viewed as just another politically appointed commission doing what they are told by the governor's

A few facts that should have been included when discussing the health-care issues.

1) The State of New Jersey does not make any payments toward a local government employee's healthcare.



All healthcare premium payments are shared between the employee and the municipality.

- 2) The employee average healthcare contribution for an individual plan in the country is approximately (public and private) \$1000.00, the approximate average in the state of New Jersey PFRS System is three times that amount.
- 3) The employee average healthcare contribution for a family policy in the country is approximately (public and private) \$4600.00, the approximate average in the State of New Jersey PFRS is twice that amount

As you can see they are distinct healthcare and financial issues that separate local government employees from the state and teacher pension and healthcare systems. The Pension and Health Benefit Study Commission has a duty to honestly address the fiscal health of the local government pension and healthcare system, it is a sustainable system that treats fairly the employee for years of service to the municipality and at the same time provides needed services to the residents of our communities without

Working closely with our counterparts at the New Jersey Association of Counties, the officers of the League of Municipalities recently submitted a statement to Gov. Christie's Blue Ribbon Pension and Health Benefit Study Commission. In that statement, we urged the commission not to weaken the vitality of the local plans in any way.

The governor, Senate President Sweeney and former Speaker Oliver, as well as other state policy makers, deserve credit for the bipartisan pension and benefit reforms that were enacted in 2010 and 2011. Coupled with the consistent payments made by responsible local governing bodies, these reforms are delivering on the promises made by their advocates. The actuaries who have studied the systems have confirmed these facts.

At the risk of delving too far into the weeds, it is important to note that when analyzing the fiscal health of public employee pension and benefit systems, experts always make a distinction between local commitments for local employees and retirees and state government's responsibility to provide funding for current and retired state employee benefits. In fact, one of the 2011 reforms included the separation of the systems — one for the state and another for the locals.

According to the latest valuation reports, the local government Public Employees Retirement System (local PERS) and the local Police and Fire Retirement System (local PFRS) are actuarially sound, in large part because

One of the most talked about programs that the Health and Safety Committee pushes is the Buscio Physical. Besides hearing about it from us, it is a frequent topic in many firehouses. Whether it is a group of guys arguing over which day they have free to schedule a group appointment, or the thirty-year veteran trying to convince the new guy to go; this is a program we are all very aware Even though the discus-

sions about the program are ubiquitous and everyone knows the importance of the screening, why do we have members who have not gone yet? As someone who has been on the Health and Safety Committee since Tom was appointed Chairman a few years ago, I have been as quilty as many. When I was first assigned to my shift out of training almost eight years ago, I was one of the new guys approached by the veteran and advised of the program, its benefits, and that I should schedule an appointment to get a "baseline". I felt this was very sound advice and truly believed I would follow through. Unfortunately I did not, and I recently went for the first time. I can't answer why I and others have put this off but laziness, fear of the unknown, the "it can't happen to me" mentality, or lack of time are all excuses I have heard and even used.

I scheduled my appointment with Cardio Pulmonary Diagnostic, LLC, which is the northern facility located at Newark Airport. The staff was extremely nice on the phone and even called me a few days before my appoint-

ment asking if I wanted to come a day earlier since they had a large group Since I was unable to cancel. reschedule I was advised that if I arrived before 7:30AM that they would have me out very quickly. I soon found out they were right. I arrived as instructed and was amazed at how streamlined the entire operation was. The longest I sat in the waiting room was to fill out the paperwork which was less than ten minutes. From this point on you will constantly be moving. I was taken in for the blood work right away since they recognize that we have been fasting since the night before. Some people recommended bringing something to eat for after the blood is drawn, but if you do not have anything there is a small area with breakfast bars, crackers, coffee and tea. As an additional note, I was advised there would be pizza delivered for lunch. Before you finish your snack you will be ushered off for more testing. These tests consist of a chest x-ray, blood pressure screening, EKG, an echo-cardiogram, a pulmonary function test, an ABI/PVR which checks the blood pressure and pulse in both arms and both ankles, and a stress test. The stress test will either be the standard treadmill stress test or a nuclear stress test. This is decided on by the doctor on a caseby-case basis.

Once all of the tests are complete you will be asked to schedule a follow-up appointment to receive your results. which will determine if you have a clean bill of health, need to make small lifestyle changes to receive the clean bill on your next screening, or if further testing is needed. At this point I looked at the clock and realized it was not even 10:30. The entire process lasted less than three hours and I was on my way home before lunch even arrived. I would like to note, however, that I only conducted the treadmill stress test. The staff advised that those who will be doing the nuclear stress test will be there approximately an hour longer.

I can honestly say that I wish I had



gone when I was first told about this program. When talking with the staff you can see that they truly believe in this program and wish more of us would attend. One way to do this is when our departments have new recruits. We should send them as one of their training days. This will get these young members on the right track to a long and healthy career. For the rest of us: we need to police ourselves and push one another to go.

Whether we make it a part of our physical fitness policies or annual health screenings is up to the individual department, but the bottom line is that we make a commitment to our health.



We have to really be careful that we do not employ residential two-story wood frame tactics when operating in those buildings that are changing the rules of the game. More often than not, we will get ourselves in a big dose of trouble.

false front and building as well and are additional areas for fire spread concerns. This can also create fire destruction of whatever is being utilized to hold the false wall to the building. Heavy smoke from behind these fronts must cause Command to seriously consider the feasibility of allowing personnel to operate in these areas. Check the rear and sides to see if access (and egress) can be gained from there. This



should be a very pessimistic operation. It is tough to get a barrier-laden building to behave. Keep good control over personnel, put Chief Officers in areas of concern as Divi-Supervision sors, and request and evaluate reports from these areas to assist in strategic decision-making.

This was a multiple alarm fire in Jersey City. Note the date on top of the structure at the cornice. It says 1895. This is structure eventually collapsed in a very complete fashion as buildings with heavy fire involvement often do. This was once a mixed residential / commercial occupancy. The top floors have used as part of the business and have been sealed over with what looks like corrugated steel panels. You can see the outline of the windows in the front wall. There is obviously a major fire spread threat to the upper floors here. Several concerns occur here:

 Access to upper floors for secondary egress is nonexistent

# Court reaffirms employer's right to look beyond Civil service rankings in promotions

The Appellate Court was recently given an opportunity to rule on an appeal of a bypass for promotion to the position of Fire Chief from a candidate who had ranked second on the Civil Service promotional list and was bypassed in favor of the third ranked eligible.

In an unpublished decision dated August 8, 2014 App. Div. Docket No. A-0241-12T1, the second ranked eligible argued that (a) the examination was improperly opened to employees serving as fire captain; (b) he was wrongfully denied disclosure of the selected eligible's personnel record and other qualifications, which were important to enable him to challenge the City's decision; and (c) the City failed to adequately state its reasons for bypassing him.

On the issue of eligibility to take the exam, the Civil Service Commission held that the appeal was untimely in that appeals from an Agency decision are to be made within twenty days of notice. The appellant failed to file within the twenty day time period. Additionally, the Commission concluded that it was authorized under its rules to expand the title scope to avoid having an incomplete list of candidates. The Commission noted that if fire captains were not eligible, there was only one deputy chief eligible who could have been the only possible candidate for promotion.

Five candidates took the examination. The City, as part of its promotional process, decided to interview the top three candidates to provide "insight as to what the candidate's thoughts were for the future of the Department, the manner in which they would handle difficult situations, and their overall work ethic." The City also reviewed the individuals' personnel files to evaluate their disciplinary and employment history.

On November 11, 2011, the City promoted the third ranked eligible and he began serving as Fire Chief on November 14, 2011. An appeal was filed on November 28, 2011.

On January 24, 2012, the City provided a statement of reasons for bypassing the first and second ranked candidates. The City stated, in part, as follows: "After evaluating each of the top three candidates under the appropriate title specifications, Captain [] was determined to be the best candidate to fill the vacant Fire Chief position based upon his positive disciplinary record in more than twentyone years as an employee...; the fact that he has demonstrated good judgment, initiative, and the ability to manage administrative functions in his performance as Fire Captain; and by virtue of his exceptional performance during his oral interview."

In its August 2, 2012 Decision, the Commission denied the appeal, finding the City's statement of reasons to be sufficient. Further, the Commission also denied the discovery request as unnecessary and in violation of the selected eligible's privacy.

In the appeal, the Court found that the Commission did not err in denying the appellant's access to the selected

eligible's personnel file. It noted that individual personnel records are "not public records and shall not be released other than to the subject employee, an authorized representative of the employee, or governmental representatives in connection with their official duties," citing to N.J.A.C. 4A:1-2.2(b). Furthermore, the Commission found that disclosure of the personnel file was unnecessary because the selected eligible's positive disciplinary record was undisputed. Moreover, the City did not rely on the selected eligible's personnel file other than to establish a lack of disciplinary history. Finally, since the City's primary reason for selecting the candidate for the position of Fire Chief was his "superior performance in an interview" and not any undisclosed material in his personnel file, there was no prima facie showing that the personnel file was germane to the City's decision. The Court also noted that the appellant, due to his position as Deputy Fire Chief, was in a position to have personal knowledge of any pertinent facts that might be in selected eligible's personnel file. The appellant failed to provide any factual basis for disclosure.

On the issue of the reasons for bypassing appellant, the Court acknowledged that under the Rule of Three. an appointing authority has flexibility in selecting a candidate for employment or promotion. The Rule permits an appointing authority to choose not to select the highest

- Disorientation of fire personnel is a very real likelihood
- Ventilation opportunities are near zero

A solid risk vs. gain assessment must be made here...and quickly. The first floor fire appears to be difficult to tame so the conditions upstairs are getting worse. Additionally, attached exposures with the possibility of open cocklofts make this an even more challenge for Command and the operating companies. This was a tough job.

As I said last month, always be prepared. Get out into the street, evaluate, and assess these structures so that you are better educated when there is fire and smoke issuing from them at 0300 hours. It is too late then.

Keep safe out there. Wear your gear ALL THE TIME!!

Continued from page 7 municipalities and counties have made full employer contributions as required under the law for more than a decade. The local PERS is currently funded (comparing assets to liabilities) at 73.9 percent and the local PFRS is currently funded at 76.9 percent. The state PERS, on the other hand, is currently funded at 48.1 percent and the state PFRS is a little better, at 50.8 percent.

These numbers matter, because they are used to determine the annual responsibility of the municipality or county – the amount that each unit of government is expected to pay into the system.

We recognize and appreciate the underlying state's funding crisis, and we commend the governor and the commission for their attention to these issues. Our concern, however, is that the commission may propose solutions for the state system that could result in new problems — and higher costs — for the local property taxpayer. That is an unintended consequence that no one wants and should be avoided.

If anyone can appreciate the challenges faced by state budget decision makers, it is local elected officials. We recognize and appreciate the challenges faced by state decision makers, as well the challenges that lie ahead.

Over the past six years, local officials deserve credit for making the tough decisions in tough times. We have pruned budgets, pursued savings, engaged in tough negotiations, reduced the workforce, shared services, cut spending, applied best practices, emptied reserve accounts and

deferred investments. We did this as property values declined, tax appeals increased, development and economic activity stalled, employment slumped and property-tax relief funding was diverted to the state budget.

Through all that, and an unprecedented series of natural disasters, local governments have continued to balance their budgets and deliver essential services, while funding numerous state-mandated responsibilities and meeting all their public employee pension funding obligations.

With this in mind, the League of Municipalities respectfully requests that the New Jersey Pension and Health Benefit Study Commission recognize that the local pension systems are healthy and that municipalities and counties have met their obligations as employers.

We are committed to advocating for legislation, regulations and policy directives that empower local governments to operate more effectively and efficiently. The League remains dedicated to advancing innovative programs and initiatives that enhance the level of service provided and save valuable taxpayer dollars.

We understand the state's budget problems and we are anxious to help in any way we can. But we cannot help in any way that shifts new burdens to our property taxpayers and our dedicated public servants.





The active member will have to submit a copy of work ID and the retiree a copy of the pay stub that they receive, blocking out and vital information, but leaving their name and the NJ retiree pension info and entering the address the pension check has stamped on it.

Once they submit the proof of eligibility (name badge) or retiree status, the discount should appear in 1 to 2 billing cycles.

ranked candidate and provides discretion to consider "other merit criteria".

In reviewing the statement of reasons provided by the City, the Court reaffirmed that "other merit criteria"

could include "preference for an advanced degree..., the performance of the applicant at the give-and-take of an interview, or character and employment references...." Here, the City provided specific reasons for its decision to bypass the appellant. In addition to noting the individual's positive disciplinary record, the City also cited to the selected eligible's "exceptional performance in an oral interview, noting he best articulated a management style consistent with the City's approach to developing and managing the operations of the Department, building a consensus, and offering a positive public face to the Department." In denying the appeal, the Court found that the City's decision was "not made for discriminatory or invalid reasons."

Finally, on the issue of the fire captains' exam eligibility, the Appellate Court agreed with the Commission's decision that appellant's appeal as to that issue was barred as untimely.

Thus, it is important to note that public employers are given wide latitude in making promotions and exercising their right under the Rule of Three especially when it comes to "other merit criteria". There is no standard that an employer must follow in terms of weighing certain factors over others. While a key factor still remains ranking within the top three on a promotional list to fill a vacancy, public employers may give substantial weight to other merit and fitness factors as determined by each employer. As stated by the Court, the "possibilities are endless."
